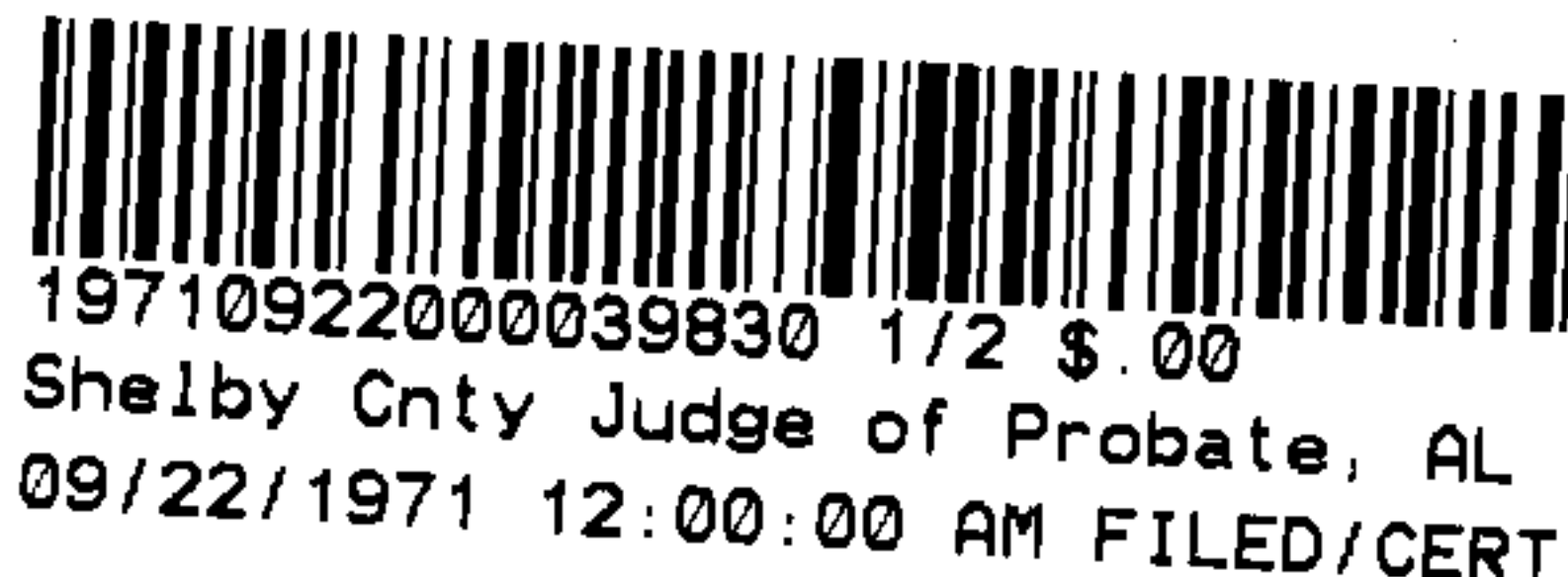

ASSIGNMENT



THIS ASSIGNMENT made and entered into this 27th day of July, 1971 by and between FLETCHER PROPERTIES, OF ALABAMA, INC., an Alabama corporation ("Assignor") and FIRST AMERICAN INVESTMENT CORPORATION, FIDELITY CAPITAL CORPORATION, FIRST GEORGIA INVESTMENT CORPORATION, CSRA CAPITAL CORPORATION and GREAT SOUTHERN ENTERPRISES, INC. ("Assignees");

W I T N E S S E T H:

WHEREAS, the Assignor is indebted to the Assignees pursuant to promissory notes of the Assignor and Fletcher Properties, Inc. of even date herewith; and

WHEREAS, the Assignees have required that the Assignor enter into this Agreement as security for said indebtedness;

NOW, THEREFORE, for and in consideration of the mutual covenants, conditions and promises made herein, the loans made by Assignees to Assignor and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, it is agreed as follows:

Assignor does hereby sell, transfer, convey and set over unto Assignees all of its right, title and interest in and to that certain Option Agreement, dated June 1, 1970 by and between W. Houston Blount, Winton M. Blount, Glenn Ireland, II, Sam Boykin, Jr., John M. Bradley, Jr., Harry E. Murphy, Thomas J. Newman, as Optionors, the wives of the Optionors and Paul Z. Fletcher and Jerome S. Fletcher, as Optionees, as amended by instrument dated April 1, 1971, which Agreement was assigned and transferred to the Assignor by the Optionees;

This Assignment shall secure all obligations and indebtedness of Assignor to Assignees, joint or several, of every kind and nature, however evidenced, whether now existing or incurred from time to time hereafter, whether created
