## PARTIAL RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, Richard C. Lovelady and wife, Peggy M.

WHEREAS, the said Lake O'Springs, Inc. has been dissolved by appropriate legal proceedings and all of the assets of said corporation have been transferred, assigned and conveyed by operation of law to the directors of said corporation who are the undersigned James E. Templeton, Whit L. Millsap, D. D. Brooks, Clarence E. Smith, Jr., and Wilbur M. Sutter; and

WHEREAS, the said mortgage provides therein for a partial release of up to one acre abutting on Lake O'Springs on written request of the mortgagors and the mortgagors furnishing to the undersigned trustees and former directors of Lake O'Springs, Inc., a survey of the portion of the real property to be released from the lien of said mortgage; and

WHEREAS, said mortgagors have furnished to the trustees and former directors of Lake O'Springs, Inc., a survey showing a sketch of real property to be released from the lien of said mortgage and also a legal description of same.

NOW, THEREFORE, in consideration of the premises and the sum of One Dollar (\$1.00) in hand paid to the said James E.

A parcel of land in the SW 1/4 of the NE 1/4 of Section 18, Township 20 South, Range 2 West, Shelby County, Alabama, shown as Lot 1 and Lot 2 on a map title Lake O'Springs, dated 23rd day of December, 1959 and signed by Edward A. Rogers, Sr., Registration Number 1623, more particularly described as follows: Commence at the SW corner of said 1/4-1/4 section; thence in a northerly direction along the west line of said 1/4-1/4 section, a distance of 429.9 feet; thence 90° right, in an easterly direction, a distance of 204.62 feet to the most southerly corner of said Lot 1; thence 140°41' left, in a northwesterly direction, a distance of 140 feet to the point of beginning; thence 180° in a southeasterly direction along the southwesterly line of said Lot 1, a distance of 140 feet; thence 62°29' left, in a northeasterly direction, a distance of 187 feet; thence 88° left, in a northwesterly direction, a distance of 152 feet to the bank of the lake; thence in a southwesterly direction meandering along the bank at the water line, a distance of 310 feet, more or less, to the point of beginning, containing 0.75 acres, more or less.
