Personally appeared before me the undersigned authority for and in the said County and said State, Cecil Nelson, who being by me first duly sworn, deposes and says that he was acquainted with Robert Merriweather during his lifetime; that he recalls when the said Robert Merriweather went into possession of property, hereinafter described, more than fifty (50) years ago, which property is described as follows:
