


STATE OF ALABAMA

SHELBY COUNTY



Before me, the undersigned authority in and for said County in said State, personally appeared Myrtle Wood, who, after being by me first duly sworn to speak the truth, deposes and says:

My name is Myrtle Wood. I am 69 years of age and have been familiar with the hereinafter described land since 1926, said land being described as follows:

A part of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 29, Township 19 South, Range 2 East, described as follows: Commence at the NW corner of said $\frac{1}{4}$ - $\frac{1}{4}$ Section and run East along North line 210 feet for point of beginning of parcel herein described; thence run South perpendicular to North boundary of said $\frac{1}{4}$ - $\frac{1}{4}$ Section for 210 ft.; thence turn angle to left and run East parallel with North line for 210 feet; thence turn an angle to left and run North parallel with West line for 210 feet; to North line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section; thence Westerly along North Line 210 feet to point of beginning; situated in Shelby County, Alabama.

I am one and the same person who purchased the above described land along with other land from W. C. and H. G. Campbell on June 15, 1926, as shown by deed recorded in Deed Book 91, page 112 in the Probate Office of Shelby County, Alabama, At the time the said W. C. Campbell and H. G. Campbell executed said deed, they were both single. I know that W. C. and H. G. Campbell were the sons of and only children or heirs of H. L. Campbell and Mary M. D. Campbell, both of whom were deceased when I purchased the land mentioned above, along with other land. At the time I purchased said land from W. C. and H. G. Campbell as mentioned above, I paid some cash down and made them a mortgage back or agreement to pay for \$200.00, which was paid about 2 years later and then said mortgage or agreement was surrendered to me and I owe no balance on said land. There has been called to my attention a tax sale in Tax Sale Record 9, page 426, in said Probate Office, showing the sale in the name of Gardner Campbell to the State of Alabama, covering said land and other land for nonpayment of taxes for the year 1926. Actually, I sent the money to pay the taxes, but through some inadvertance, the person overlooked it, but yesterday, there was a redemption of said tax sale and the matter was cleared up. After I purchased the above described land, as mentioned above, I went into immediate possession of all of this land, with the other land I purchased at that time and rented the dwelling house until 1930 when I moved into said house situated in the Northwest corner of said 40 acres, and which is near the above described land. My husband and I cultivated the land for the first three or four years after which I rented it out to tenants who cultivated it each and every year until I sold it. Part of the above described land was joined by the yard and was not cultivated and we occupied it as part of our home place, until I sold the same to my son, Donald E. Wood on April 1, 1968, as shown by deed recorded in Deed Book 256, page 262, in said probate office. My said son went into immediate possession

of said land and they cleared the land and since they purchased it, drilled a well on it and are now preparing to build a dwelling house on it and affiant says throughout all the years that she has known the above described land, including the other one acre parcels that I conveyed to my other children, all of which deeds are recorded in the Probate Office of Shelby County, the same has been in possession of affiant and Donald E. Wood and the other three acres mentioned have been in possession of my other children and this has been true since I first purchased the land in 1926, and I paid taxes on the land until I sold the same and occupied it and lived on it and throughout all the years no persons have contested my title or disputed my possession.
