said GRANTOR does by these presents, grant, bargain, sell and convey unto

David William Campbell and wife, Joyce H. Campbell

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor
of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate,
situated in the County of Shelby, State of Alabama, to-wit:

TRACT #25: From the Northeast corner of the Northeast Quarter of Southeast Quarter
of Section 34, Township 20 South, Range 3 West, Shelby County, Alabama, run southerly
along the east boundary line of said Quarter-Quarter section for 250.0 feet; thence turn
an angle of 91 degrees 13 minutes 39 seconds to the right and run westerly for 525 feet to
the point of beginning of the land herein described; thence continue along the last said
