## Agreement not to Encumber or Transfer Real Property

- (a) "Borrowers" will pay all taxes, assessments, dues and charges of every kind imposed or levied, or which may be imposed or levied, upon their real property prior to the time when any of such taxes, assessments, dues or charges shall become delinquent and
- (b) "Borrowers" will not, without the consent in writing of "Bank" first had and obtained,
  - 1. Create or permit any lien or other encumbrances (other than presently existing liens) to exist on the following described real property, or
  - 2. Transfer, sell, hypothecate, assign, or in any manner whatever dispose of the following described real property, situated in the County of Shelby, State of Alabama

Beginning at a point located as follows: From the S.W. corner of S.E. \$\frac{1}{4}\$ of N.E. \$\frac{1}{4}\$ of Section 29, Township 19 South, Range 2 West, run east along the south line of S.E. \$\frac{1}{4}\$ of N.E. \$\frac{1}{4}\$ for a distance of 356.13 feet; thence turn an angle to the left of 91 degrees 25' 15" and run a distance of 657.32 feet to a "Point of Beginning"; at said "Point of Beginning" turn an angle to the right of 91 degrees 23' 15" and run a distance of 306.05 feet; thence turn an angle to the left of 91 degrees 23' 30" and run a distance of 328.67 feet; thence turn an angle to the left of 88 degrees 36' 15" and run a distance of 306.0 feet; thence turn an angle to the left of 91 degrees 23' and run a distance of 328.66 feet to the "Point of Beginning".

It is further AGREED and understood that if default be made in any of the terms hereot, or of any instrument executed by "Borrowers" in connection herewith, or in the payment of any indebtedness or obligation of "Borrowers", now or hereafter owing to "Bank", then "Bank" may, at its election, in addition to all other remedies and rights which it may have by law, declare the entire remaining unpaid principal and interest of any such obligations or indebtedness then remaining unpaid to the "Bank" immediately due and payable.

	It is further AGREED and understood that the "Bank", in its discretion, is hereby authorize by "Borrowers" to cause this instrument to be recorded at such time and in such places as "Ba	d and permitted nk" may, in its
