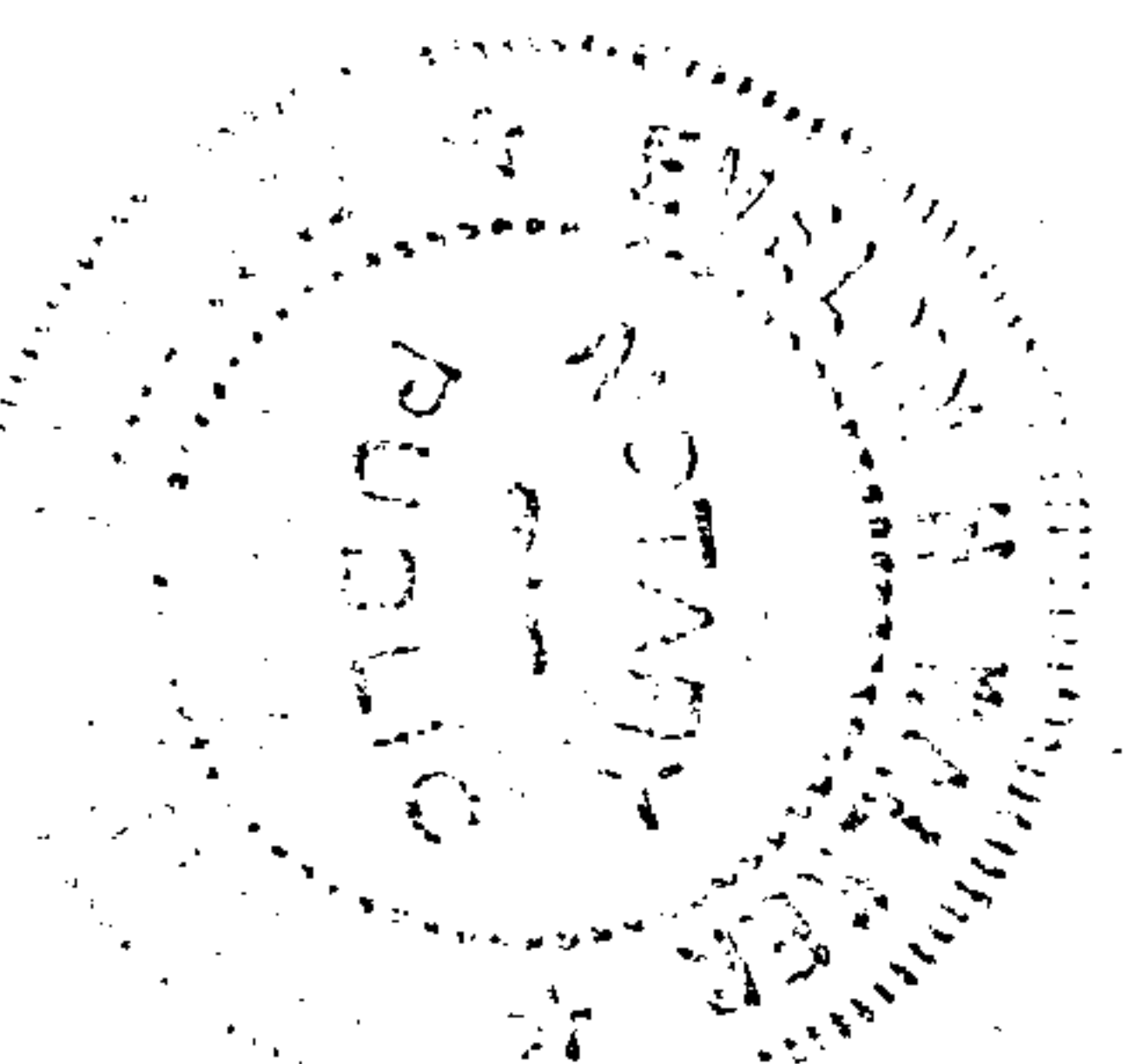
do hereby grant, bargain, sell and convey unto the said Charles L. Brasher
