WHEREAS, the FIRST SOUTHERN METHODIST CHURCH of Helena, Alabama, has been succeeded by and its name changed to CEDAR GROVE INDEPENDENT BIBLE CHURCH pursuant to the monthly and special called conference of February 3, 1971, a copy of the Minutes of which are attached hereto, and

WHEREAS, the CEDAR GROVE MEMORIAL ASSOCIATION is desirous of continuing said lease to the CEDAR GROVE INDEPENDENT BIBLE CHURCH,

IT IS, THEREFORE, UNDERSTOOD and AGREED between the said CEDAR GROVE INDEPENDENT BIBLE CHURCH and the CEDAR GROVE MEMORIAL ASSOCIATION that the aforementioned lease, a copy of which is attached hereto and is incorporated by reference as if set out in full herein, be and is hereby amended so that in
