KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of Thirty-six Thousand Seven Hundred Thirty-two and no/100 Dollars, to the undersigned grantors Woodrow W. Stillwell and wife, Mildred Boyd Stillwell in hand paid by Kimberly-Clark Corporation, the receipt whereof is hereby acknowledged, the said Woodrow W. Stillwell and wife, Mildred Boyd Stillwell, do hereby grant, bargain, sell and convey unto the said Kimberly-Clark Corporation, all merchantable pine *W.W.S.* 8" stump 6" above ground ~~and charriwood~~ sawtimber and pulpwood, except those trees which are marked as seed *M.B.S.* trees, located on the following described land, to-wit:

The SW $\frac{1}{4}$ of Section 25, Township 18 South, Range 2 East and approximately 10 acres in the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 26, east of Highway 231 in Township 18 South, Range 2 East, containing 170 acres, more or less; situated in Shelby County, Alabama.

together with full and free right of ingress and egress to and from said land at any and all times until the expiration of one year from the date of the execution of this deed, for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber and at the expiration of said time, said land and all uncut timber shall revert to the grantor herein.

The grantee is hereby given the right to use existing private roads and has the right to build such temporary roads and other devices as may be necessary or useful to the grantee for the purpose of cutting and removing the timber.
