Begin at the SE corner of SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 11, Township 20 South, Range 3 West; thence run North along East line of said $\frac{1}{4}$ $\frac{1}{4}$ Section a distance of 548.57 feet; thence turn angle of 88 deg. 27' to the left and run a distance of 190.70 feet; thence turn an angle of 66 deg. 24' to the left and run a distance of 598.42 feet to the South line of said $\frac{1}{4}$ $\frac{1}{4}$ Section; thence turn an angle of 113 deg. 36' to the left and run East along the South line of said $\frac{1}{4}$ $\frac{1}{4}$ Section a distance of 445.11 feet to the point of beginning. Situated in the SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 11, Township 20 South, Range 3 West, Shelby County, Alabama. Containing 4.00 acres.
