lowing described real estate, situated in      Shelby      County, Alabama, to-wit:



Thence continue North along the East line of said  $\frac{1}{4}$   $\frac{1}{4}$  section a distance of 320.00 ft., thence turn an angle of 143 deg. 55 min. to the left and run a distance of 308.70 ft. to the North Margin of an existing county gravel road. Thence turn an angle of 104 deg. 53 min. to the left and run along the North margin of said road a distance of 195.00 ft. to the point of beginning. Situated in the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Sec. 14, T22S, RLW, and containing 0.67 acres.
