## RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

and wife \_\_\_\_\_ of the  
 County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

feet in width on \_\_\_\_\_ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a \_\_\_\_\_ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project No \_\_\_\_\_ as recorded in the office of the Judge of Probate of Shelby County.

Commence at the Southeast corner of the NW $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 33, T-19S, R-1E and run North along the East boundary line of said quarter quarter section a distance of 310.0 feet to the point of beginning in the center of present dirt road; thence continue North along said East boundary line and crossing the center line of Project CP4-159 at station 28+74 a distance of 150.0 feet to a point on the Northeast 40 foot Right of Way line of said project; thence run Northwesterly along said 40 foot Right of Way line along a curve to the right (concave Northeasterly) and having a radius 778.51 feet a distance of 11.0 feet to a point 40.0 feet left of P. C. station 27+88.8; thence run N 28° 37' W along said 40 foot Right of Way line a distance of 560.0 feet to a point on the North property line of said grantor; thence run West along said property line and crossing the center line of said project at staion 22+08 a distance of 75.0 feet to a point in the center of present dirt road; thence run Southeasterly along the center of said dirt road a distance of 750.0 feet to the point of beginning.

Said parcel of land is lying in the NW $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 33, T-19S, R-1E and contains 0.69 acres more or less including that part now occupied by the present dirt road.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
