

## RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

and wife

County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

feet in width on \_\_\_\_\_ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a \_\_\_\_\_ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project No S-5910 (101) as recorded in the office of the Judge of Probate of Shelby County.

Commence at the southeast corner of the NW $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 18, T 20 S, R 3 W and run west along the south boundary of said quarter quarter section and crossing the centerline of Project S-5910 (101) at Station 5+58 a distance of 593.0 feet to a point on the northwest 50 foot right of way line of said project; thence run N 30°53'W along said northwest right of way line a distance of 121.0 feet to the point of beginning; thence continue N 30°53'W along said northwest right of way line a distance of 578.0 feet to a point 50 feet left of P. C. Station 12+85.0; thence run northwesterly along said northwest right of way line along a curve to the left (concave southwesterly) and having a radius of 3224.04 feet a distance of 71.0 feet to a point on the north property line of said grantor; thence run east along said north property line and crossing the centerline of said project at Station 13+25 a distance of 118.0 feet to a point on the northeast 50 foot right of way line; thence run southeasterly along said northeast right of way line along a curve to the right (concave southwesterly) and having a radius of 3324.04 feet a distance of 13.0 feet to a point 50.0 feet right of P. C. Station 12+85.0; thence run S 30°53'E along said northeast right of way line a distance of 398.0 feet to a point on the east property line of said grantor; thence run south along said east property line and crossing the centerline of said project at Station 8+00 a distance of 208.0 feet to the point of beginning.

Said parcel of land is lying in the NW $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 18, T 20 S, R 3 W and contains 1.21 acres, more or less.
