County, Alabama.

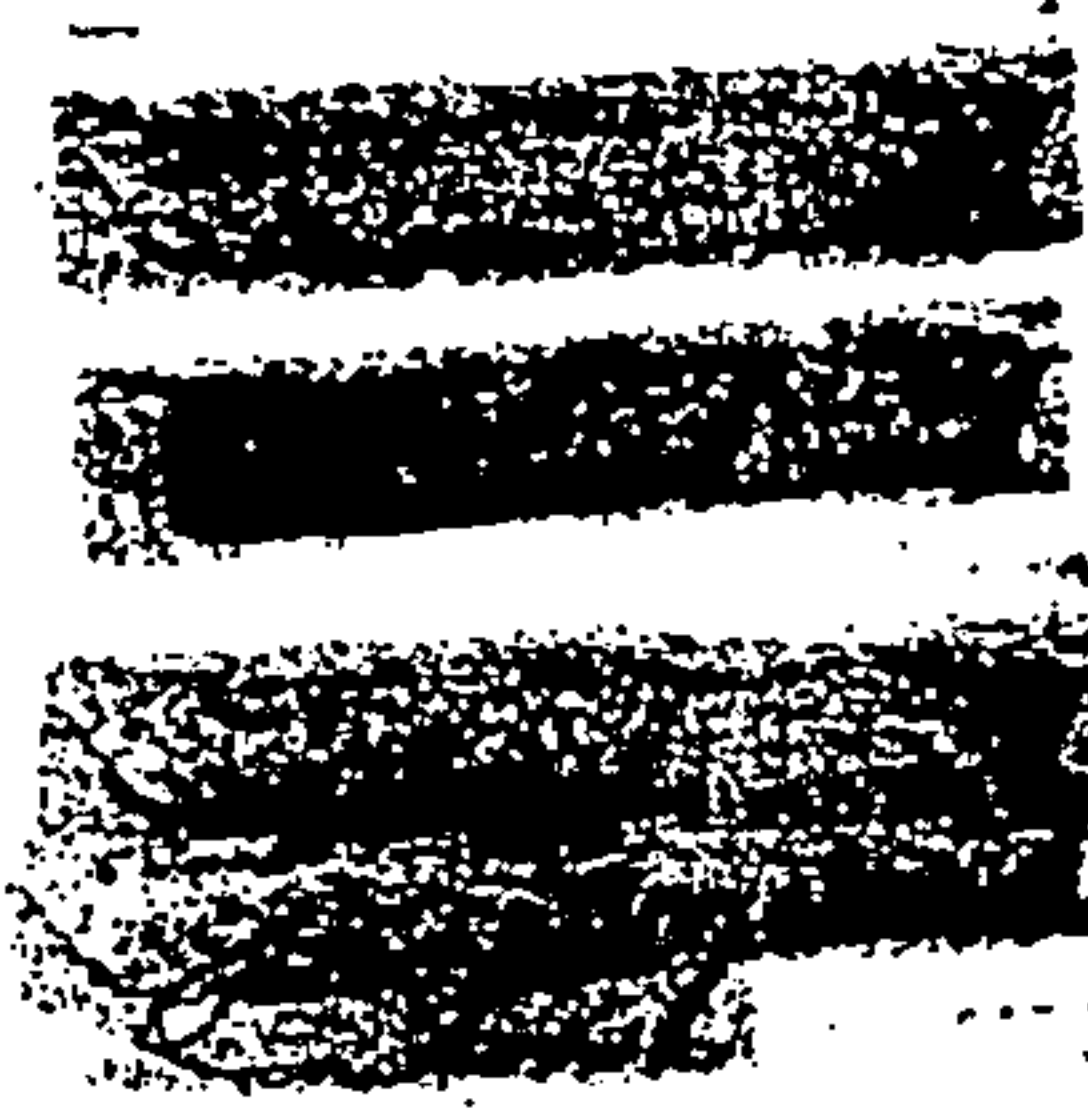
