PARCEL A

along said right of way line 797.2 feet to the SE corner of the Towyery
Lot. Thence at a deflection angle of 82°42' right along the East side
of the Towyery lot a distance of 272 feet more or less to a point 20
feet North of the NE corner of the Towyery lot, which is point of
beginning. Thence continue in a straight line North 332 feet more or
less to the right of way of the Southern Railroad Company. Thence
