KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

_____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ see below _____ foot right-of-way across our lands, said right-of-way herein conveyed being more

particularly described as follows, to-wit: And as shown on the right-of-way map of Project No. _____ as recorded in the office of the Judge of Probate of Shelby County.

Commence at the southwest corner of the SW $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 32, T 20 S, R 4 W (on the Shelby County & Jefferson County boundary line) and run north along said line a distance of 751 feet, more or less, to the point of beginning on the south 30 foot right of way line of Project CP3-40; thence run northeasterly along said right of way a distance of 60 feet, more or less, to the point of intersection with the existing south 40 foot right of way line of said project; thence run north along said existing right of way a distance of 60 feet to a point on the north right of way line of the parcel of land herein described; thence run southwesterly along said north right of way line a distance of 60 feet, more or less, to a point on the Shelby County & Jefferson County boundary line; thence run south along said Shelby County and Jefferson County boundary line a distance of 60 feet to the point of beginning.

Said parcel of land is located in the SW $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 32, T 20 S, R 4 W and contains 0.083 acre, more or less, including that part now occupied by the present road.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
