As a part of the consideration for the execution of this conveyance, the Grantee herein does hereby assume and agree to pay, according to the terms thereof, an undivided 20 % of a certain mortgage and the note which it secures, which mortgage and note have been executed by the Grantor herein to Margaret M. Dunston in the amount of \$80,000.00. It being understood that Grantee herein shall have an obligation to pay 20 % of the annual installments due on said mortgage and should he fail to make such payment, then his interest in subject property shall be encumbered to the extent of such failure in favor of the party who does make such payment.

It is also understood that the title to subject property is subject to a certain Buy-Sell Agreement entered into by and between the parties who own all of the interest in and to said land.

heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances; except as set forth hereinabove;


