(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

From the S.W. corner of the N.E. 1/4 of the N.E. 1/4, Sec. 7, T-21-S, R-2-E, run east along the south boundary of said 1/4-1/4 a distance of 156.15 ft. to the point of beginning; thence, left 100 deg. 21' a distance of 22.52 ft.; thence, right 104 deg. 15' a distance of 103.96 ft.; thence, right 75 deg. 19' a distance of 15.18 ft.; thence, right 110 deg 47' a distance a distance of 102.51 ft. to the point of beginning, except that part which lies below elevation 397 based on mean sea level datum.

There is also conveyed to grantees, their heirs, successors, and assigns the right to use the present boat launching site of grantors on Lay Lake for the purpose of launching boats for their private use, together with the right to fish from the bank of Lay Lake on property now owned by grantors.
