Sixty-nine Thousand, One Hundred, Fifty and No/100-----Dollars

a corporation, in hand paid by James Richard Walker and Helen H. Walker  
the receipt whereof is acknowledged, the said Stan Parker Builder, Inc.

does by these presents, grant, bargain, sell, and convey unto the said  
James Richard Walker and Helen H. Walker  
as joint tenants, with right of survivorship, the following described real estate, situated in  
Shelby County, Alabama, to-wit:

Lot 6, in Block 8, according to the Survey of Kerry Downs, Subdivision of Inverness, as  
recorded in Map Book 5, Page 135, in the Office of the Judge of Probate of Shelby County,  
Alabama.

SUBJECT TO: (1) Current taxes; (2) Easements as shown by record plat; (3) Restrictions,  
conditions and limitations in Misc. Book 5, Page 86, and Misc. Book 5, Page 268;

heirs, executors and assigns forever, against the lawful claims of all persons.

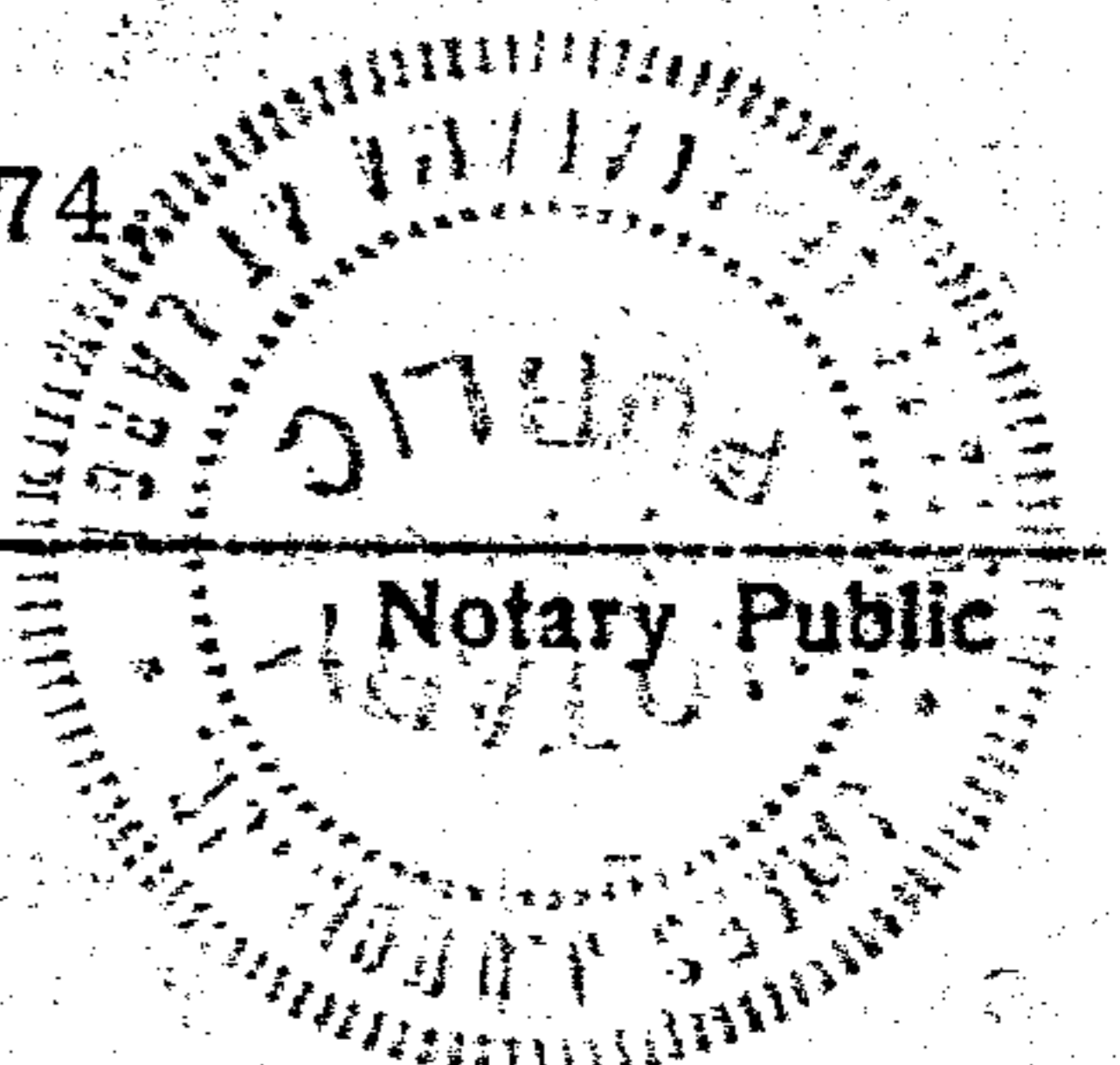
