That in consideration of FIVE THOUSAND DOLLARS (\$5,000.00) & other good and valuable consideration DOLLARS

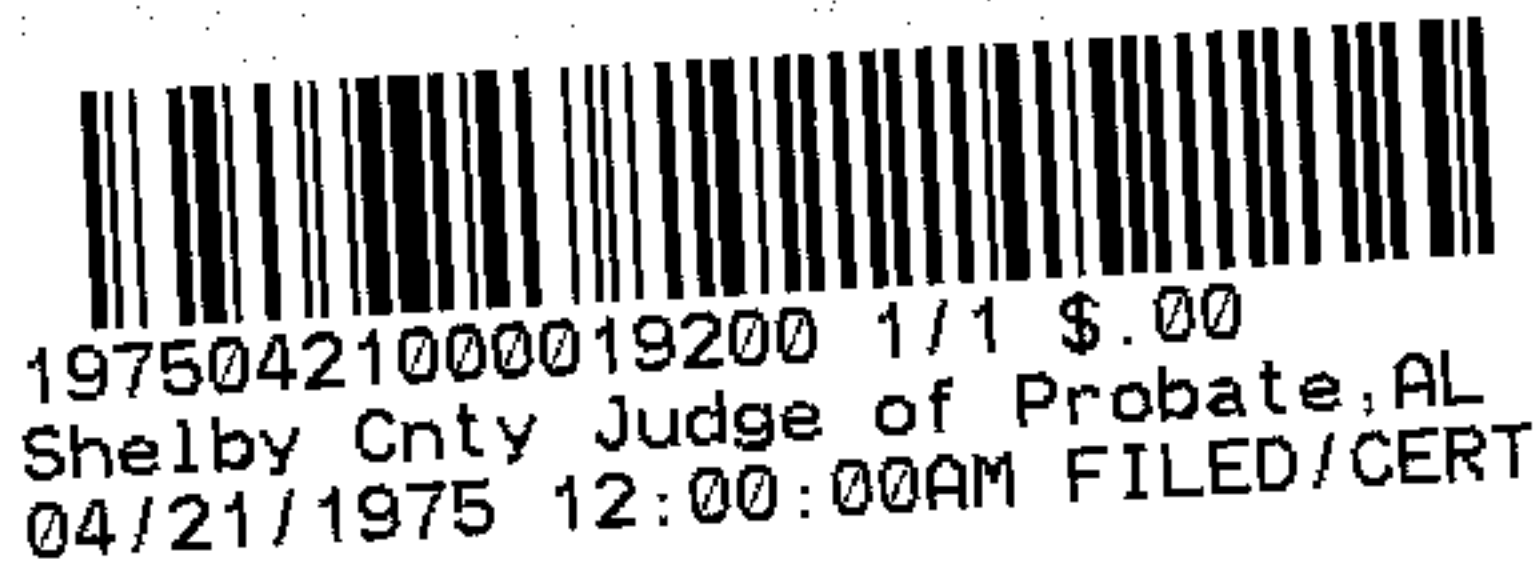
