the receipt whereof is acknowledged, the said Trimm Construction Company, Inc.

does by these presents, grant, bargain, sell, and convey unto the said  
Jerry Allen Dees and wife, Linda G. Dees  
as joint tenants, with right of survivorship, the following described real estate, situated in  
Shelby County, Alabama, to-wit:

Lot 3 in Block 2 according to Map of Cahaba Valley Estates, 6th Sector, as recorded  
in Map Book 6, Page 25, in Probate Office of Shelby County, Alabama. Minerals and  
mining rights excepted. Situated in town of Pelham, Shelby County, Alabama.

Subject to:

1. Taxes for 1975 and subsequent years.
  2. Restrictive Covenants and Conditions filed for record on 24th July, 1974, in Misc. Book 8, Page 640. And this this binder insures that said covenants and conditions have not been violated and that a future violation will not result in a forfeiture or reversion of title.
