KNOW ALL MEN BY THESE PRESENTS, That in consideration of TEN DOLLARS and other good and valuable consideration to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, H. Commence at the NE corner of the NW $\frac{1}{4}$ of SW $\frac{1}{4}$, Section 5, Township 21 South, Range 1 East, Shelby County, Alabama, and run thence Westerly along the northern boundary of said $\frac{1}{4}$ $\frac{1}{4}$ Section a distance of 30 feet to a point; thence run Southerly parallel with the Eastern boundary of said $\frac{1}{4}$ $\frac{1}{4}$ Section and along the Western boundary of Bradley Drive a distance of 375.0 feet to a point; thence turn an angle of 89 deg. 15' to the right and run Westerly along the southern boundary of Lot No. 9 according to the map of Bradley Estates a distance of 146.0 feet to the Southwest corner of said Lot No. 9; thence turn to the left and run southerly parallel with the eastern boundary of said $\frac{1}{4}$ $\frac{1}{4}$ Section a distance of 40 feet to a point, which said point is the Northeastern corner of Lot No. 5 of Bradley Estates; thence continue in the same direction a distance of 317.0 feet to a point, which said point is the Southeastern corner of said Lot No. 5; thence turn to the right an angle of 89 deg. 15' and run Westerly a distance of 300 feet to a point, which said point is the Southwestern corner of Lot No. 6 of Bradley Estates; thence turn to the right an angle of 90 deg. 45' and run Northerly a distance of 317.0 feet to a point, which said point is the Northwestern corner of said Lot No. 6 of Bradley Estates; thence turn to the right an angle of 89 deg. 15' and run Easterly a distance of 300 feet to the point of beginning.
