LEGAL DESCRIPTION

FOR SOUTH CENTRAL BELL RIGHT OF WAY

A 10 foot Right of Way for South Central Bell, being more particularly described as follows:

Commence at the N.W. Corner of Lot 5, Block 5 of Southwind, First Sector, as recorded in Map Book 6, Page 72, in the Probate Office of Shelby County, Alabama, this being the Point of Beginning of a 10 Foot Easement herein described; Thence from said Point of Beginning, run Westerly along a dedicated Right of Way (Caribbean Circle) 10.0 Feet; Thence turn Left 90° and run Southerly and parallel to the West line of said Lot 5, 120.0 feet; Thence turn Left 90° and run Easterly 10 feet to the S.W. Corner of said Lot 5; Thence turn Left 90° and run Northerly along the West line of said Lot 5, 120.0 feet to the Point of Beginning.

Commence at the N.E. Corner of Lot 5, Block 1 of Southwind, First Sector, as recorded in Map Book 6, Page 72 in the Probate Office of Shelby County, Alabama, this being the Point of Beginning of a 10 Foot Easement herein described; Thence from said Point of Beginning run East along a dedicated Right of Way (Caribbean Circle) 10 feet; Thence turn Right 90° and run South and parallel to the East line of said Lot 5, 120.0 feet; Thence turn Right 90° and run West 10 feet to the S.E. Corner of said Lot 5; Thence turn Right 90° and run North along the East line of said Lot 5, 120.0 feet to the Point of Beginning.
