WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS: That in consideration of One Thousand and no/100 Dollars and other good and valuable consideration, to the undersigned grantors, in hand paid by the grantees herein, the receipt whereof is acknowledged, we Carolyn R. Payne and husband, Charles Ray Payne, herein referred to as grantors, grant, bargain, sell and convey unto Wayne Preston Blackerby and wife, Mary E. Blackerby, herein referred to as grantees, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot No. 5 of Sector Two of Alabaster Highlands Subdivision, as recorded in Map Book 5 Page 13, in the Office of the Probate Judge, Shelby County, Alabama.

This Lot No. 5 herein described and conveyed is subject to the Protective Covenants shown on Map of Alabaster Highlands Subdivision as recorded in Map Book 4 Page 43 in the Office of the Probate Judge, Shelby County, Alabama.
