KNOW ALL MEN BY THESE PRESENTS, That whereas the undersigned Grantors, Robert S. Waite and Frank W. Hardie, as trustees under the Nell D. Waite trust instrument dated the 27th day of December, 1961 for the benefit of Mary Henderson Waite, a minor, did in their capacity as trustees under said trust instrument acquire an undivided one-tenth (1/10) interest in the following described property by deed executed by Nell D. Waite and spouse on December 27, 1961 which said deed was recorded in the Probate Office of Shelby County, Alabama on December 30, 1961 and appears of record in Map Book 218, Page 767 and acquired an additional one-tenth (1/10) interest in the following described property by deed executed by Nell D. Waite and spouse on December 28, 1962 which said deed was recorded in the Probate Office of Shelby County, Alabama on December 31, 1962 in Map Book 223, Page 791; and

WHEREAS said trust instrument provided that the trust shall last until the beneficiary thereof, namely, Mary Henderson Waite, shall attain the age of twenty-one (21) years and upon said beneficiary attaining the age of twenty-one (21) years the trustees shall transfer and deliver all of the property then constituting the trust estate to said beneficiary; and

WHEREAS Mary Henderson Waite has attained the age of twenty-one (21) years;

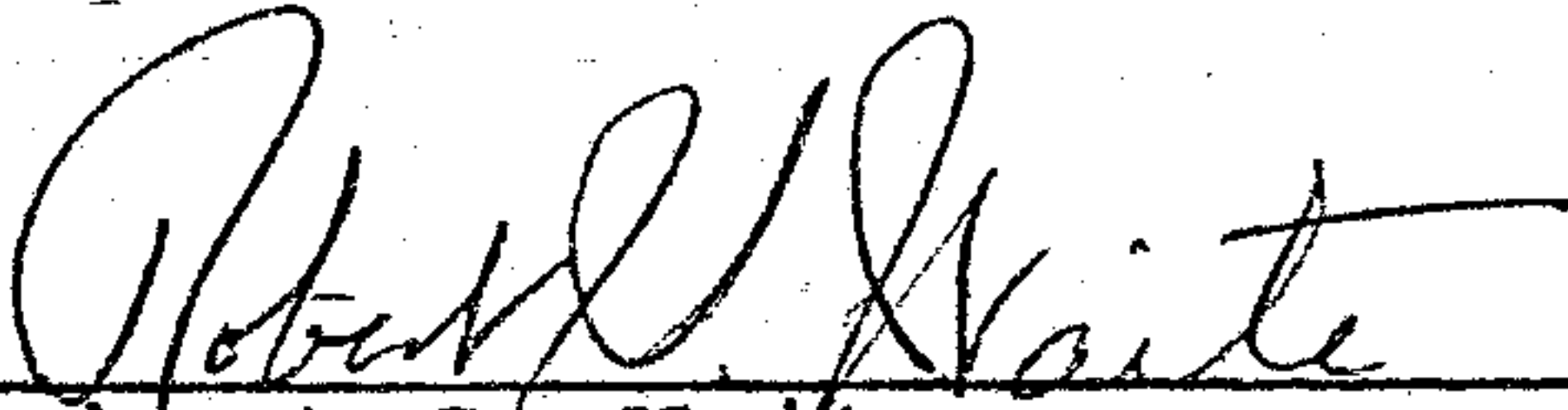
NOW THEREFORE in consideration of the premises and in fulfillment of the obligation imposed upon the Grantors as trustees under the aforesaid trust instrument the Grantors in their capacities as trustees under the aforesaid trust instrument do hereby grant, bargain, sell and convey to the said Mary Henderson Waite (the daughter of Nell D. Waite) an undivided one-fifth (1/5) interest in and to the following described real estate situated in Shelby County, Alabama, to-wit:

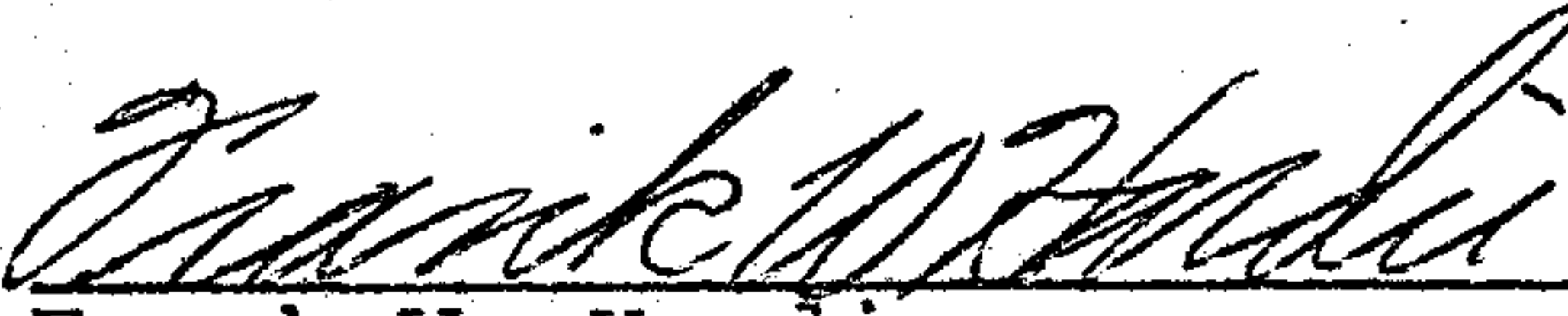

A tract of land located in Section 31 and Section 32, Township 19 South, Range 2 West, described as follows: Commence at the NW corner of said Section 31, Township 19 South, Range 2 West, and run North 89° 45' East along the North line of said Section 3,325 feet to a point midway between the NW and NE corner of the NW quarter of NE quarter of said Section 31; thence South 2° 6' East 1,327 feet to the South line of said NW quarter of NE quarter; thence South 28° 40' East 1,486.9 feet to the SE corner of the SW quarter of NE quarter; thence South 46° 6' East to a point on the SE boundary of a right-of-way for a public road which said point is the point of beginning of the property herein described; thence continue South 46° 6' East to the center of a canal; thence up the center of the canal to its intersection with the creek; thence up the meanderings of said creek to a line running South 15° East and intersecting the South line of said Section 32, 995 feet east of the Southwest corner of said Section 32; thence South 15° East along said line a distance of 1,515 feet to the South line of said Section; thence South 89° 30' West along the South line of Section 32 and of Section 31 1,825 feet; thence North 30° 20' West to the Southeast boundary of the right-of-way for the above-referred-to public road; thence Northeast along said Southeast boundary of the right-of-way for said public road to the point of beginning.
