This agreement, made this the 27 day of Other, , 1976, by and between Robert L. Burr and wife, Virginia Johnson Burr, hereinafter referred to as the Grantors, and Peter M. Button & Sandra L. Button, hereinafter referred to as Grantee: WITNESSETH, THAT,

WHEREAS, both Grantors and Grantee are owners of adjoining tracts of land in Shelby County, Alabama, and

WHEREAS, it is for the mutual benefit of both parties hereto that Grantors grant to Grantee an easement for ingress and egress over the land of Grantor to the land of Grantee.

Now, therefore, in consideration of the premises and the sum of ten dollars, in hand paid by the Grantee, the receipt and sufficiency of which is hereby acknowledged by the Grantors, the Grantors do hereby grant to the Grantee a permanent easement for ingress and egress, whether on foot, by automobile or other vehicles, over, on, upon and across certain lands of the Grantors in Shelby County, Alabama, as shown on the attached survey and which is more particularly described as follows:

Commence at the SW corner of the SE% of the NW% of Sec. 33, T19S, R2W; thence run in a northerly direction along the West line of said quarter-quarter for 691.34' to a point in the centerline of a proposed fifteen foot (15') Ingress and Egress Easement across the land of R. L. Burr; thence turn a deflection angle of 120°27'20" to the right for a distance of 1.73'; thence continue along the centerline of said proposed easement through a curve to the right for 16.45' (arc distance), said curve having a central angle of 39°42'50" and a radius of 23.73'; thence continue along the centerline of said proposed easement for 19.89' to the North line of the land of Peter Button and the end point of the proposed easement.

To have and to hold the same unto the said Grantee and his assigns for the use and purposes for which said land is granted, forever.
