That in consideration of Ten (\$10.00)----- DOLLARS,  
and other good and valuable considerations

the receipt of which is hereby acknowledged, the said Chambers Realty Company, Inc.

does by these presents, grant, bargain, sell and convey unto the said Rose Mary Chambers Bennett

the following described real estate, situated in Shelby County, Alabama, to-wit:  
Lot 2 in Block 1, "Eckmann Subdivision" according to map as recorded in Map
