Begin at the N.E. corner of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 11, Township 24 North, Range 12 East and run southerly along the east side of the said quarter-quarter for 71.05 ft., then turn an angle of 117 deg 48 min to the right and run 224.91 ft., then turn an angle of 62 deg 12 min to the right and run 355.14 ft. to the point of beginning. Then continue along the same line for 65.00 ft., then turn an angle of 84 deg 32 min to the left and run 94.70 ft., then turn an angle of 84 deg 32 min to the right and run 230.00 ft., then turn an angle of 84 deg 32 min to the left and run 448.38 ft. to a point on the east side of a lake. Then turn an angle of 96 deg 17 min 41 sec to the left and run 284.69 ft., then turn an angle of 82 deg 35 min to the left and run 540.17 ft. back to the point of beginning.

Also begin at the N.E. corner of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 11, Township 24 North, Range 12 East and run southerly along the east side of the said quarter-quarter for 71.05 ft., then turn an angle of 117 deg 48 min to the right and run 224.91 ft., then turn an angle of 62 deg 12 min to the right and run 650.14 ft., then turn an angle of 84 deg 32 min to the left and run 543.18 ft. to the point of beginning (said point also being on the east side of a lake).
