3. Transmission line permit to Alabama Power Company recorded in Probate Office of Shelby County, Alabama, in Deed Book 112, Page 132.

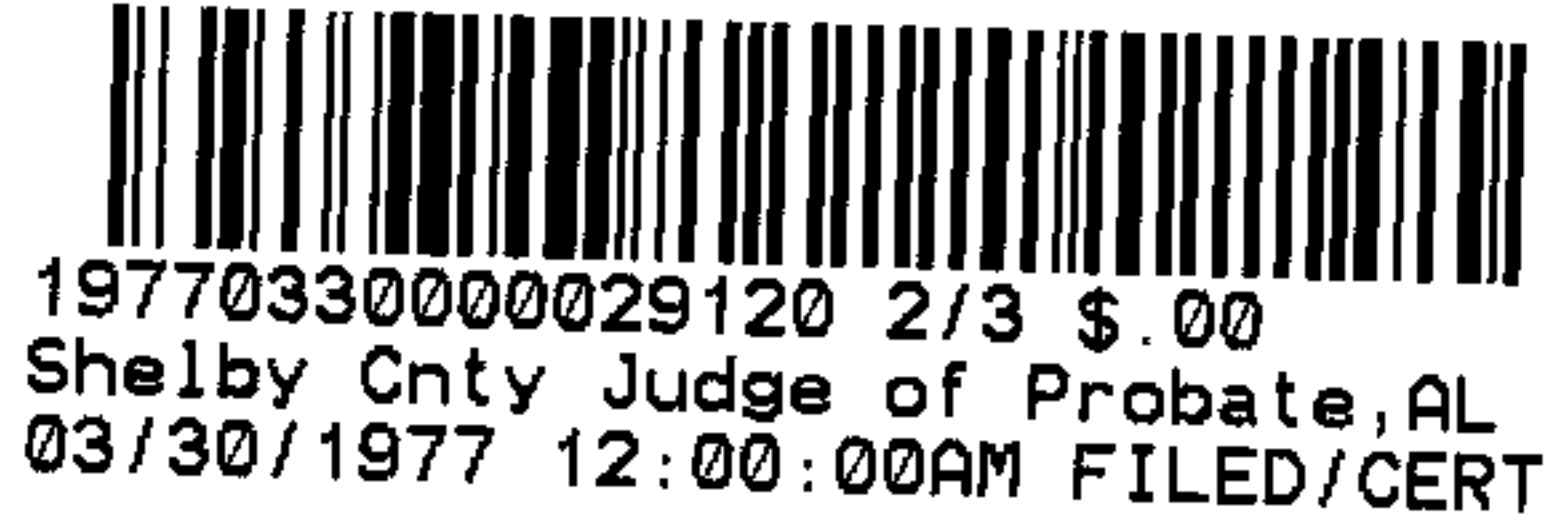
