KNOW ALL MEN BY THESE PRESENTS: That I, Marion Kenneth Morgan, a resident citizen of Jefferson County, Alabama, and over the age of 21 years, being of sound mind and disposing memory, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking any other wills made by me.
