Westbrook, Jr. who was heretofore duly appointed by the order of this court and who now consents to act as guardian ad litem for Margaret Elizabeth Morgan, minor heir of said deceased; and it appearing to the court that the acceptance of service and/or waiver of notice by the next of kin of said decedent have been filed in this court, and the court having ascertained by sufficient evidence that the signature affixed thereto is the genuine signature of said next of kin; and it further appearing to the satisfaction of the court that notice of the filing of said petition and of the time appointed for hearing the same has been given in pursuance of law and in strict accordance with the former order of this court made and entered in this cause; now, on motion of said petitioner, the court proceeds to hear said petition; and, after due proof and hearing had according to the laws of this state, the court is satisfied and is of the opinion that said instrument is the genuine last will and testament of said deceased, and that such instrument should be probated as the last will and testament of said deceased. It is, therefore,

ORDERED, ADJUDGED AND DECREED by the court that said instrument be duly admitted to probate as the last will and testament of Marion Kenneth Morgan, deceased, and ordered to be recorded together with the proof thereof and all other papers on file relating to this proceeding. It is further ordered that petitioner pay the costs of this proceeding.
