KNOW ALL MEN BY THESE PRESENTS, that whereas A. M. Harper, W. K. Murray, J. Reese Murray, J. B. Davis, and A. M. Harper, Trustee executed a certain mortgage to the undersigned, which mortgage is recorded in Mortgage Book 325, page 680, in the Probate Office of Shelby County, Alabama.

NOW, THEREFORE, in consideration of the sum of \$1.00 and other good and valuable considerations, receipt whereof is hereby acknowledged, the undersigned does hereby release from the lien and operation of said mortgage the following described real estate, to-wit:

A tract of land situated in the Northwest 1/4 of the Northeast 1/4 of Section 5, Township 20 South, Range 1 East, Shelby County, Alabama, being more particularly described as follows: Commence at the Southwest corner of the NW 1/4 of the NE 1/4 of Section 5, Township 20 South, Range 1 East, Shelby County, Alabama, and run in a Northerly direction along the West line of said 1/4-1/4 section a distance of 238.85 feet to a point; thence turn a deflection angle of 43° 13' to the right and run in a Northeasterly direction a distance of 17.98 feet to the point of beginning; thence continue in a Northeasterly direction along the projection of the last described course a distance of 336.95 feet to a point; thence turn an interior angle of 132° 33' and run to the right in an Easterly direction a distance of 727.50 feet to a point on the Southwest right-of-way line of a County Road; thence turn an interior angle of 106° 10' and run to the right in a Southeasterly direction along the Southwest right-of-way line of said County Road a distance of 258.45 feet to a point; thence turn an interior angle of 73° 50' and run to the right in a westerly direction a distance of 1,027.32 feet to the point of beginning.

This release shall not in any way impair or effect the right of the mortgagee to hold the remainder of the premises conveyed by said mortgage and not hereby released as security for that part of the mortgage indebtedness remaining unpaid.
