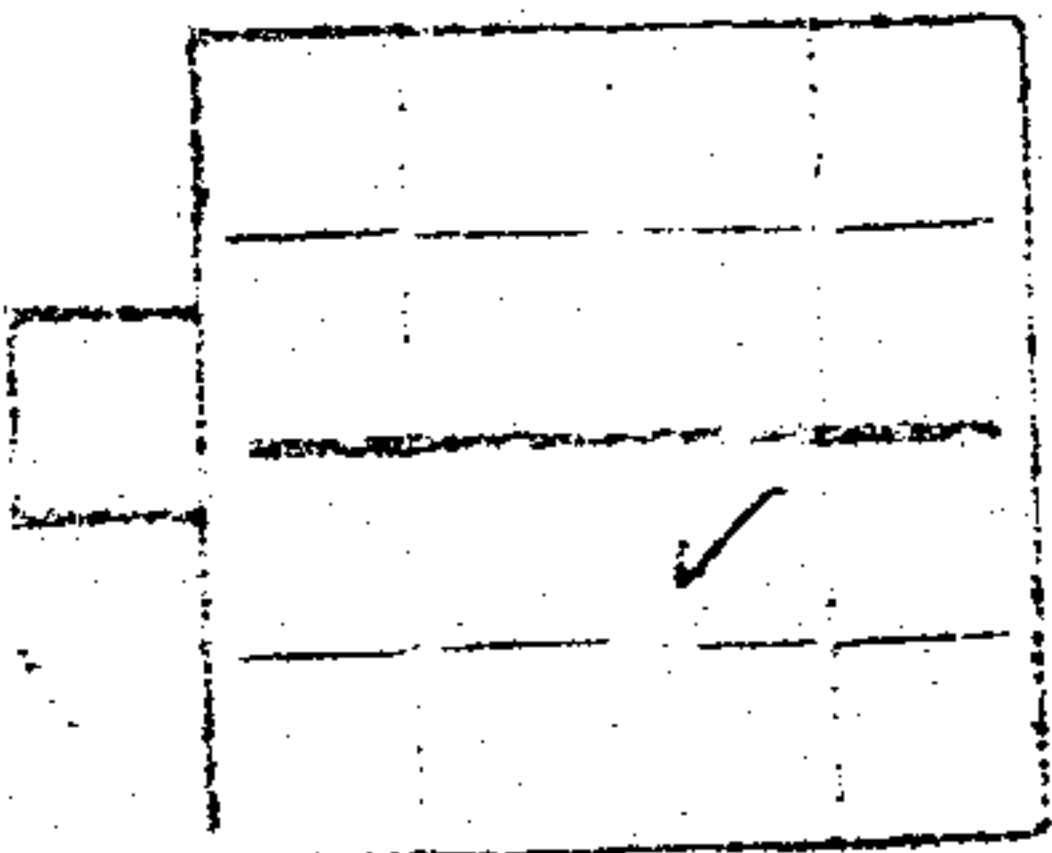

install, operate and maintain, along routes to be selected by the grantee,
(generally shown crosshatched on the attached drawing) its successors or
assigns, all poles, wires, conduits, cables, trans closures and other appli-
ances and facilities useful or necessary in connection therewith for the
overhead and underground transmission and distribution of electric power and
for the overhead and underground communication service, upon, over, under and
across the following described land, situated in Shelby
County, Alabama:

A parcel of land in the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 19,
Township 19 South, Range 2 West, more particularly
described as follows: Commence at the SW corner of
Said NW $\frac{1}{4}$ of SE $\frac{1}{4}$; thence east along south line of said
forty 243.91 feet; thence North 55 degrees 46 minutes
east 5.09 feet for a point of beginning; thence continue
said course 382.62 feet, thence north 2 degrees 41 minutes
east 203.88 feet to the south right of way of Harland
Drive; thence northwesterly along said drive to the
intersection of the NE right of way of Riverchase Parkway
East; thence southeasterly along said parkway to the point

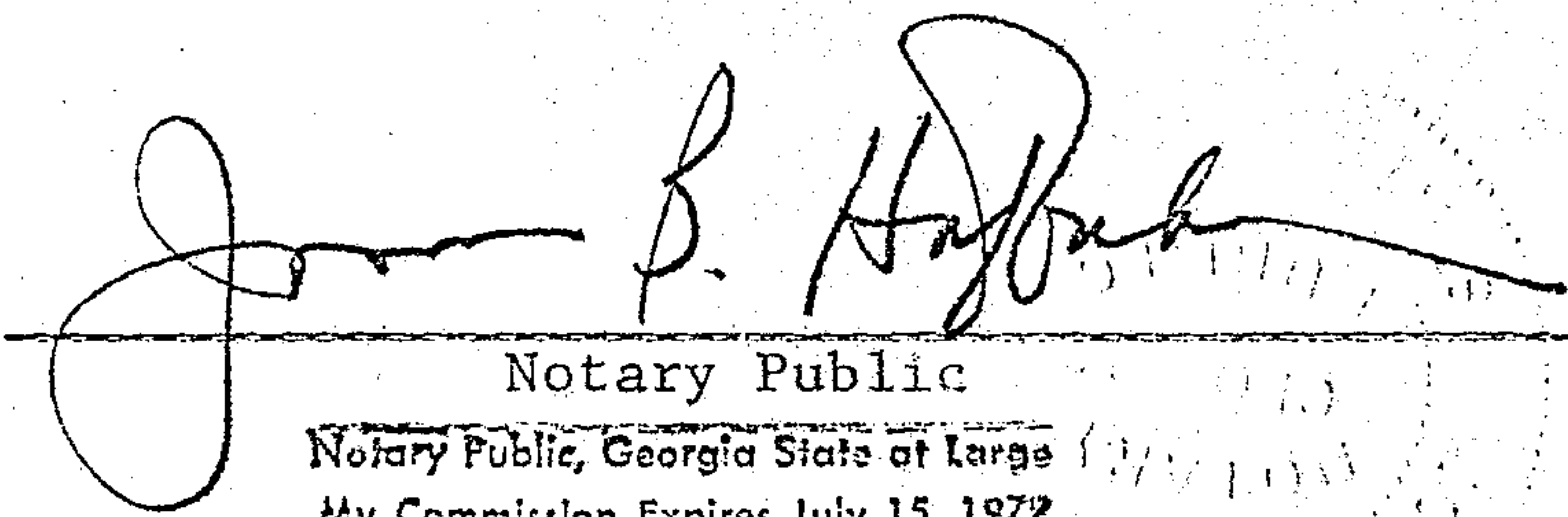

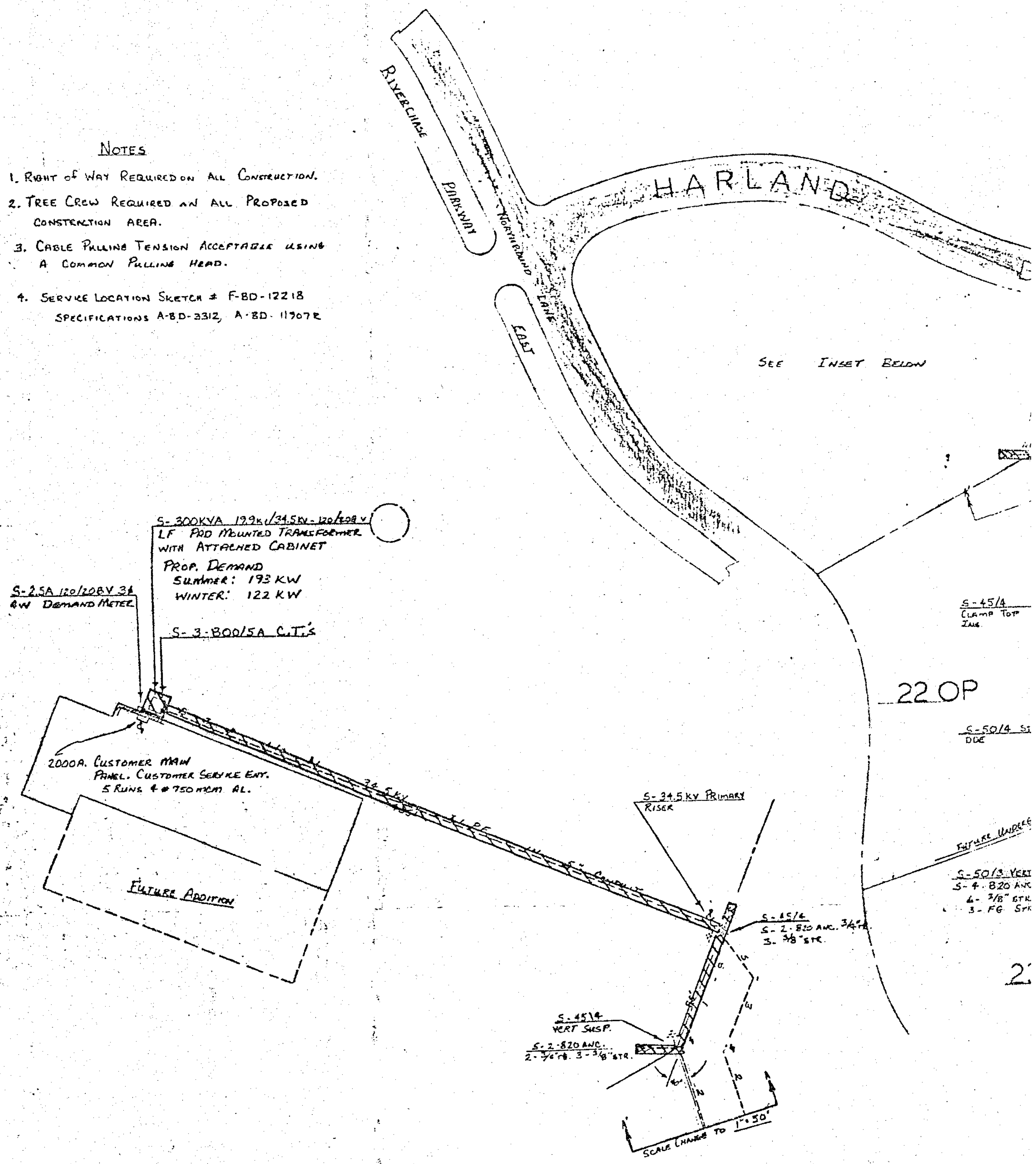

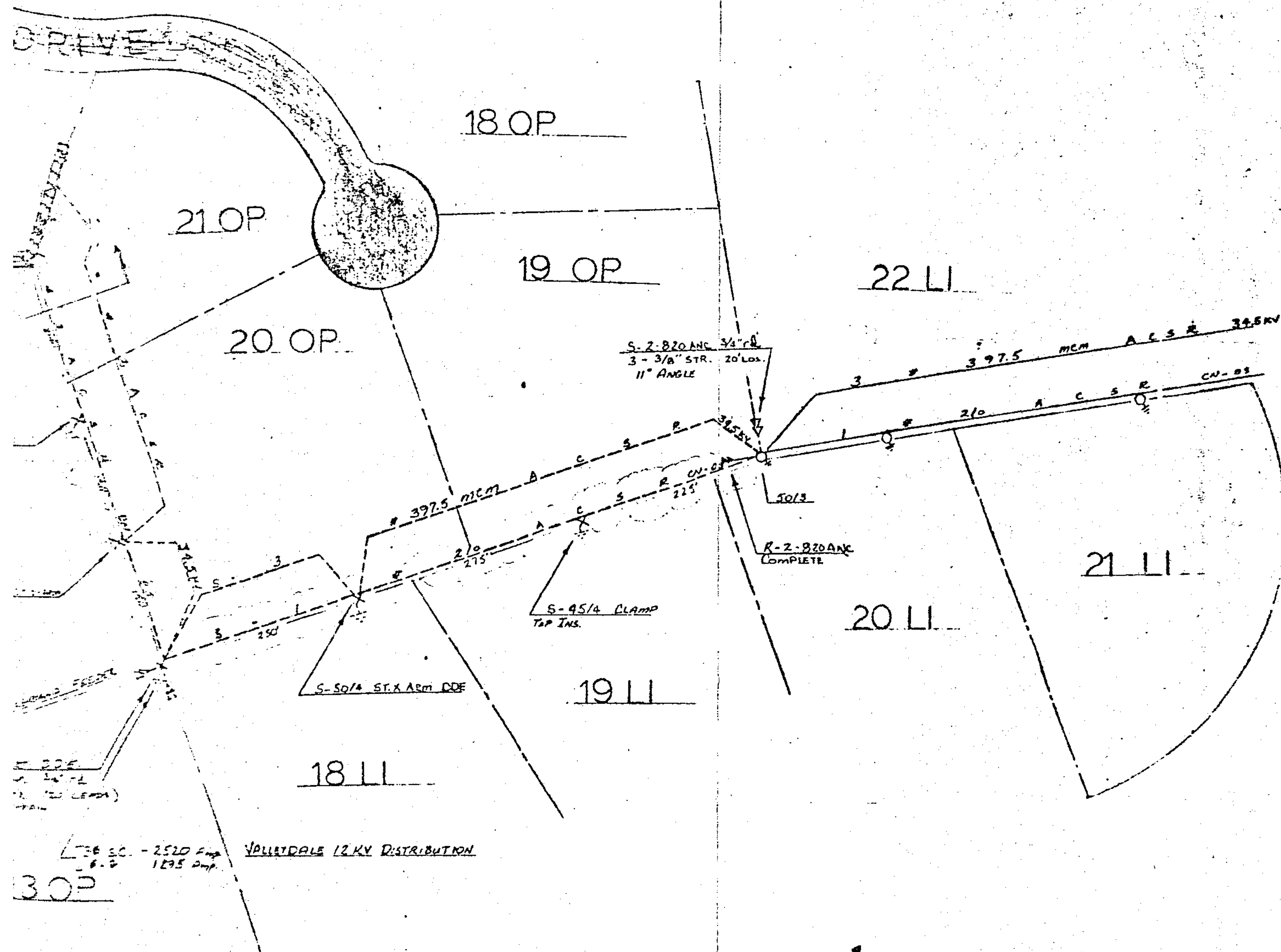
