KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of One Dollar (\$1.00)

in hand paid to the undersigned, the receipt whereof is hereby acknowledged, the undersigned Juanita A. Isbell

hereby remises, releases, quit claims, grants, sells, and conveys to Elgin F. Isbell

(hereinafter called Grantee), all her right, title, interest and claim in or to the following described real estate, situated in Shelby County, Alabama, to-wit:

Begin at the SE corner of the NW 1/4 of SE 1/4 of Section 10, Township 18, Range 1 East; thence run North along the East line of said 1/4-1/4 section 400 feet; thence turn an angle of 90 degrees to the left and run 220 feet; thence turn an angle of 90 degrees to the left and run 400 feet to the South line of said 1/4-1/4 section; thence run East along the south line of said 1/4-1/4 section 220 feet to the point of beginning.

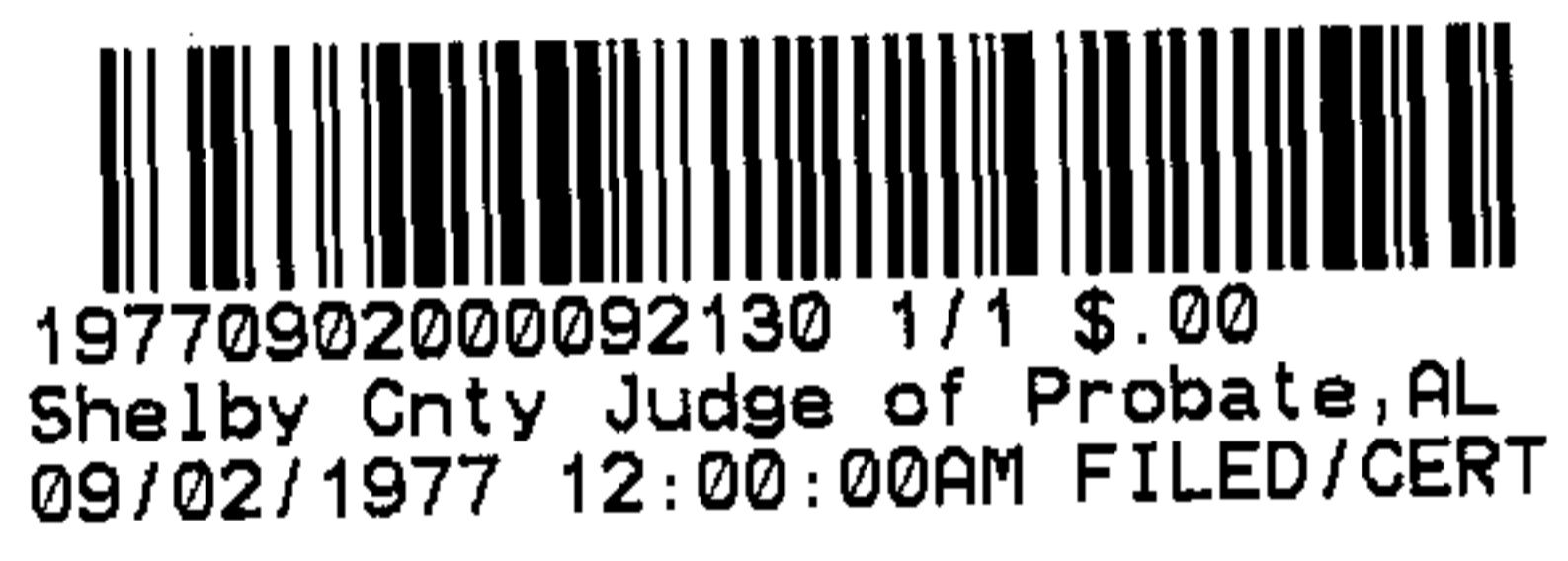
ALSO: Commence at the SE corner of the NW 1/4 of SE 1/4 of Section 10, Township 18, Range 1 East and run thence North along the east line of said 1/4-1/4 section 400 feet to the point of beginning; thence turn an angle of 90 degrees to the left and run 240 feet; thence turn an angle of 34 degrees 30' to the right and run 166.3 feet to the east right of way of a county road; thence run North 30 degrees East along the east right of way of said road 282 feet; thence run South 77 degrees 30' East 255 feet to the east line of said 1/4-1/4 section; thence run South along the east line of said 1/4-1/4 section 275.9 feet to the point of beginning.
