EXHIBIT "A"

A part of SW 1/4 Section 11, T19S, R1W; more particularly described as follows; Commence at the NE corner of NW 1/4 of SE 1/4 of said section and run West along North line of said 1/4-1/4 section 781.65 feet to the centerline of a County Road (said point being 153.4' Southwest of point of curve of said County Road) thence an angle to the left of 43 degrees 11 minutes and run in a Southwesterly direction along said centerline of County Road 1451.0 feet to the point of curve of a curve to the left; thence continue in a Southwesterly direction along tangent of said curve 139.0 feet; thence an angle to the right of 105 degrees 33 minutes and run in a Northwesterly direction 38.72 feet to Northwesterly right-of-way of said County Road to the point of beginning of tract herein described. Thence continue along same course 356.22 feet; thence an angle to the left of 110 degrees 33 minutes 30 seconds and run in a Southwesterly direction 375.0 feet; thence an angle to the left of 69 degrees 26 minutes 30 seconds and run Southeastwardly 342.59 feet to the Northwesterly right-of-way of said road; thence turn an angle to the left and run along said road right-of-way 371.28 feet to the point of beginning of the parcel of property herein described in Shelby County, Alabama.
