EXHIBIT "A"

Parcel One

Commencing at the intersection of the south boundary of Alabama Highway 25 with the west boundary of County Road No. 61 in the town of Wilsonville, Alabama, and run in a westerly direction along the south boundary of said Highway 25 a distance of 210 feet, more or less to what was formerly known as the old J. F. Pope home site and is now owned by Scruggs; thence turn an angle of 90 deg. to the left and run a distance of 41 $\frac{1}{2}$ feet to the northwest corner of the following described lot; (formerly referred to as T. M. Reinhardt and D. F. Bolton lot); thence run in an easterly direction parallel with said Highway 25 a distance of 210 feet to County Road No. 61; run thence along the west boundary of said County Road No. 61 a distance of 41 $\frac{1}{2}$ feet to the point of beginning;

Parcel Two

Commencing at the southeast corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 1, Township 21, Range 1 East, which corner is marked by an iron stake, run thence north 39 deg. and 50 min. west 203 feet to a point on the east side of sidewalk, which is marked by an iron pin for point of beginning; run thence in a westerly direction at right angle to said sidewalk 100 feet; turn thence an angle of 90 deg. to the right and run in a northerly direction parallel with sidewalk 56 feet; turn thence an angle of 90 deg. to the left and run 110 feet; thence turn an angle of 90 deg. to the right and run 22 feet; thence turn an angle of 90 deg. to the right and run in an easterly direction along the line dividing the first and second buildings south of Highway 25, being the south line of the above described Parcel One, a distance of 210 feet to the east side of sidewalk; run thence in a southerly direction along east side of sidewalk 78 feet to the point of beginning;

Parcel Three

Lot Nos. 1 and 2 in Wilsonville, as shown on Horsley's map of Wilsonville, the same lying north of Southern Railway and west of Main Street and south of the above described Parcel Two and being more particularly described as follows: Lot bounded on the east by County Highway 61, on the south by the Southern Railway right-of-way, and on the west by property formerly owned by Juanita T. Williams (being Parcel Four herein), and on the north by the above described Parcel Two.

Parcel Four

Begin at a point where the west line of that certain street dividing Dewey F. Bolton's business houses and the Southern Railway Depot lot crosses the north line of Southern Railway Company's right-of-way and run along said right-of-way in a westerly direction 91.30 feet to the point of beginning of the lot herein conveyed; thence north 12 deg. 26 min. west 108.92 feet; thence south 77 deg. 34 min. west 83.50 feet; thence south 12 deg. 26 min. east 124 feet to the right-of-way of said Railway Company; thence along same north 62 deg. 20 min. East 8 feet to the southwest corner of Town of Wilsonville's tank property; thence along the west line of said tank property north 27 deg. 40 min. west 50 feet; thence along the north line of said tank property north 62 deg. 20 min. East 66 feet; thence along the east line of said tank property south 27 deg. 40 min. east 50 feet to said right-of-way of said Railway Company; thence along same north 62 deg. 20 min. east 11 feet to the point of beginning.

The above described parcels of land are further described as being all that real property situated north of the Southern Railway Right-of-way; west of County Road No. 61; south of Alabama Highway 25; and east of the Scruggs property in the SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 1, Township 21, Range 1 East, Wilsonville, Shelby County, Alabama, EXCEPT therefrom the 50' x 66' plot owned by the town of Wilsonville which is its tank site.
