GENERAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of Ten and No/100 (\$10.00) DOLLARS, and other good and valuable considerations to the undersigned Jonnie C. H. Morrison and husband, James A. Morrison (hereinafter Grantors), in hand paid by Robert Guy Morrison (hereinafter Grantee), the receipt whereof is acknowledged, we the said Grantors do hereby give, grant, bargain, sell and convey unto the said Grantee, the following described real estate, situated in Shelby County, Alabama, to-wit:

A tract of land situated on the West Side of the SE  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  of Section 21, Township 19 S, R 1 E, containing 14 acres more or less and more particularly described as follows according to A. W. Mead survey, Reg #1101, September 1946:

Beginning at the NW corner of said 40 and running East 630.92 feet to an iron pipe marking the NW corner of S. P. Blankenship's lot, thence South to an iron pipe marking the NE corner of Hughes' lot, thence West along North line of Hughes' lot 630.92 feet to NW corner of Hughes' lot, thence North to beginning, before described as being the NW corner of said 40.

TO HAVE AND TO HOLD, the above described lot or parcel of land, together with all and singular the rights, tenements, hereditaments, appurtenances and improvements thereunto belonging, or in anywise appertaining, unto the said Grantee, his heirs and assigns forever.
