of Probate Court of Shelby County, Alabama.

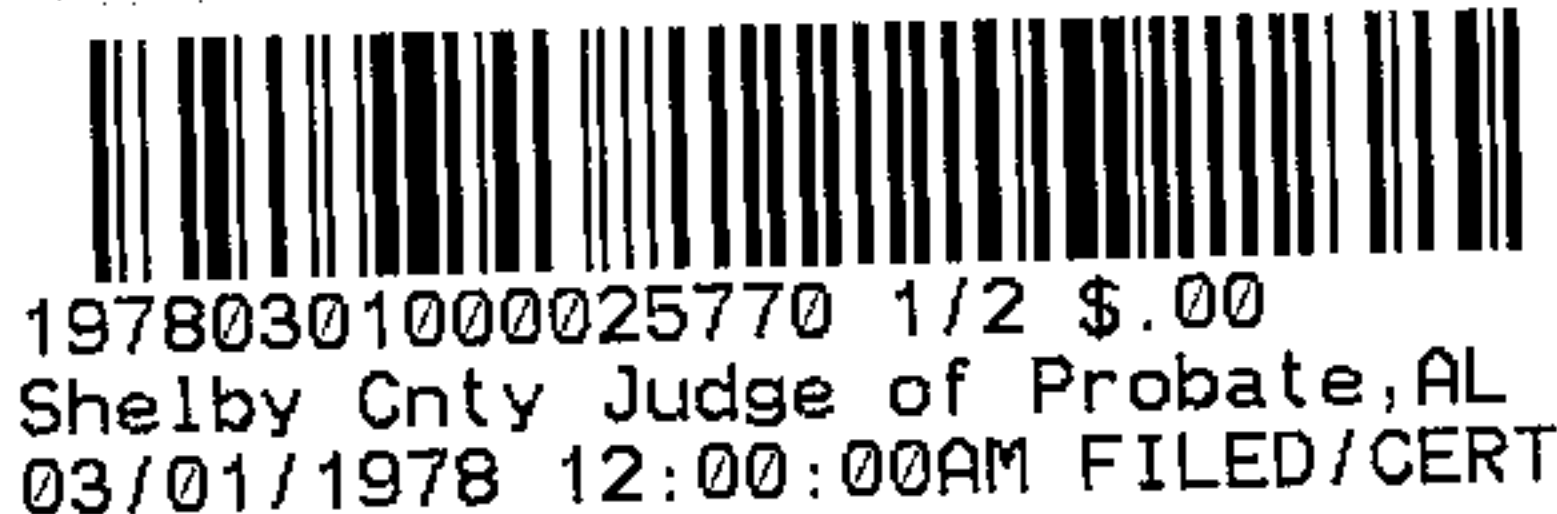
Ruth P. Coleman is the surviving grantee of deed recorded in
