That in consideration of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration

to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto
Bert N. Adams, William W. Adams, Jr. and William C. Holcombe, and to each of them
separately and severally,


(herein referred to as grantees, whether one or more), the following described real estate, situated in

Shelby County, Alabama, to-wit:

A perpetual easement and right-of-way for unlimited ingress and egress with the right to
construct and maintain a road and utilities over a strip of property 60 feet in width, or
such greater width as may be required by Shelby County for cuts and fills for a road
constructed to county standards, extended 30 feet on either side of a centerline described
as follows:

Commence at the N.E. corner of the SE 1/4 of NW 1/4 of Section 26, T19S, R1W; thence run
South along the East line of said 1/4-1/4 Section a distance of 414.60 feet to a point
on the North Right-of-Way line of U. S. Highway #280; thence turn an angle of 88 degrees,
28 minutes to the right and run along Highway #280 Right-of-Way a distance of 817.50 feet
to the point of beginning; said point being in the centerline of a 60 ft. access easement
herein described: From the point of beginning thus obtained, turn an angle of 91 degrees,
32 minutes to the right and run 957.33 feet; thence turn an angle to the right of 40 degrees,
02 minutes, 40 seconds and run 130.92 feet; thence turn an angle to the right of 11 degrees,
20 minutes, 55 seconds and run 374.05 feet; thence turn an angle to the left of 5 degrees,
25 minutes, 50 seconds and run a distance of 332.38 feet; thence turn an angle to the
right of 14 degrees, 55 minutes, 55 seconds and run a distance of 247.94 feet; thence
turn an angle to the left of 56 degrees, 15 minutes, 05 seconds and run a distance of
94.53 feet to the point of ending of said 60 ft. easement, said point being on the
South line of Section 23, T19S, R1W, Shelby County, Alabama.

Grantor reserves for herself and her future heirs, successors and assigns, the same
rights herein conveyed unto Grantees.
