Burnett and his wife, Lenora S. Burnett, (herein referred to as grantors) do grant, bargain, sell and convey unto H. Grover Mims and Mary C. Arnold (herein referred to as GRANTEEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 10, Brookstone Estates, the map of which is recorded in the Probate Office of Shelby County, Alabama, in Map Book 4, page 53.

Subject to building set back line, as shown on recorded map of said subdivision, subject to restrictive covenants recorded in Deed Book 222 at page 871, Office of Judge of Probate of Shelby County, Alabama, and subject to transmission line permits to Alabama Power Company and Southern Bell Telephone and Telegraph Company.
