FINAL JUDGMENT OF DIVORCE

THIS CAUSE, coming on to be heard, was submitted for final judgment upon the pleadings and proof as noted. Upon consideration thereof, it is ordered and adjudged by the Court as follows:

FIRST: That the bonds of matrimony heretofore existing between the parties are dissolved, and the said JEANNETT S. KIRKPATRICK and said WILLIAM ROBERT KIRKPATRICK are divorced each from the other.

SECOND: That neither party shall marry again except to each other until sixty (60) days after the date of this Judgment of Divorce, and if an appeal is taken (which must be instituted within forty-two (42) days from this Judgment, or from the date that a post-trial motion is denied), then neither party shall again marry except to each other during the pendency of the appeal.

THIRD: That the costs of Court accrued herein are hereby taxed against the Defendant for the collection of which let execution issue and if returned "no property found" then let execution for costs issue against the Plaintiff.

FOURTH: That title to the residence of the parties located at 5006 Mountain View Parkway, is hereby vested in the Plaintiff and the Defendant is divested of any right, title or interest therein. The Plaintiff shall pay the balance of the mortgage indebtedness outstanding thereon including the mortgage to American National Bank in Huntsville, Alabama.

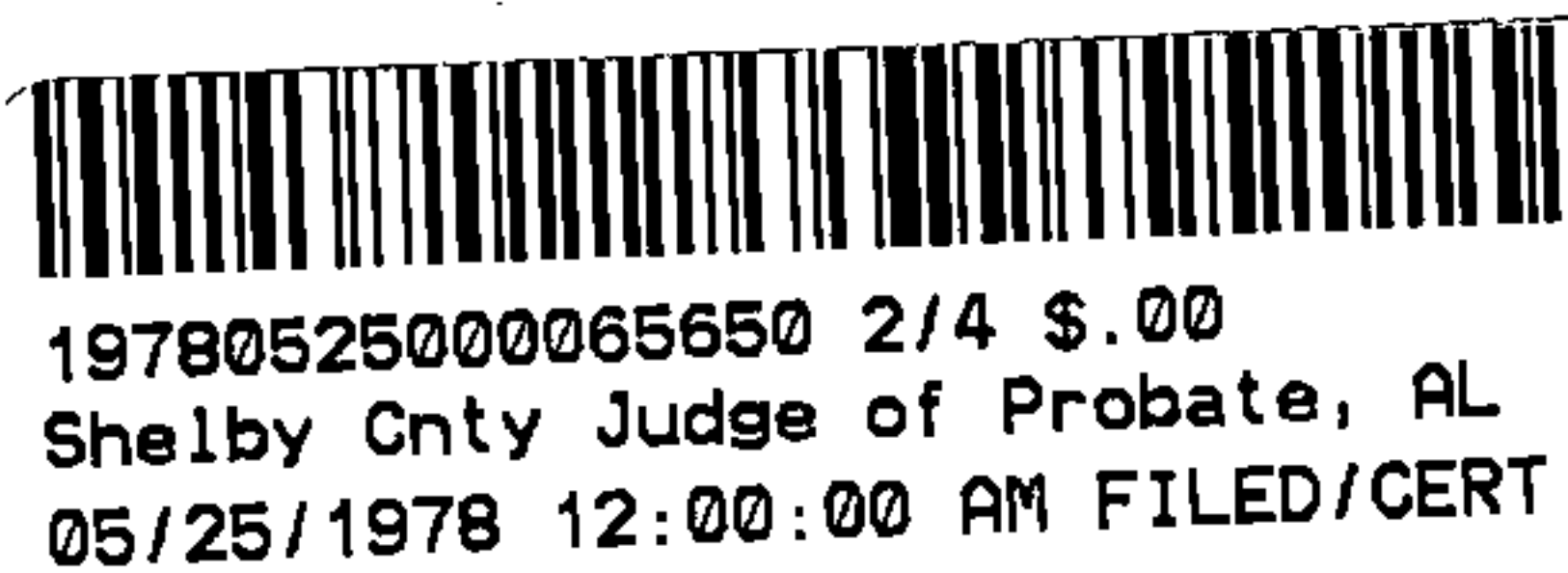

of any right, title or interest therein. The Plaintiff shall
pay any outstanding indebtedness thereon. Title to the 1973
Ford Mustang is vested in the Defendant and the Plaintiff is
divested of any right, title or interest therein. The Defendant
shall pay any outstanding indebtedness thereon.

SEVENTH: The Defendant shall pay the outstanding
indebtedness at Sears and the Plaintiff shall pay the outstanding
indebtedness at Rich's; and each party shall pay any outstanding
indebtedness incurred by that party during the marriage, except
as otherwise provided herein.

EIGHTH: Title to the Winner boat and Chrysler
motor is vested in the Defendant and the Plaintiff is divested
of any right, title or interest therein.


NINTH: Title to the Lowery Organ is vested in
