(hereinafter called Grantee), all our right, title, interest and claim in or to the fol-

lowing described real estate, situated in Shelby County, Alabama, to-wit:

Begin at the S.E. corner of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 8, T-18-S, R-2-E and run northerly along the east side of the said quarter-quarter for 145.31 ft. to the point of beginning. Then turn an angle of 89 deg 29 min 25 sec to the left and run westerly for 1161.12 ft to a point on the east right of way of Shelby County Road No. 55, then turn an angle of 115 deg 59 min 04 sec to the right and run northeasterly along the said R.O.W. for 276.38 ft., then turn an angle of 58 deg 54 min 40 sec to the right and run easterly for 1116.36 ft. to an existing iron, then turn an angle of 94 deg 33 min 01 sec to the right and run southerly for 347.77 ft., then turn an angle of 90 deg 31 min 34 sec to the right and run westerly for 75.09 ft. back to the point of beginning.
