For and in consideration of the Sum of Three Thousand Three Hundred Seventy-Eight and no hundredths Dollars (\$3,378.00), in hand paid, the undersigned Anniston Production Credit Association, A Corporation, does hereby release from that certain mortgage heretofore executed by Baker Dairy Farms, Inc., recorded in Book 308, Page 889; Book 327, Page 209; Book 339, Page 546; Book 313, Page 933; Book 318, Page 545; Book 342, Page 486; Book 348, Page 404, of the mortgage record of the Judge of Probate, Shelby County, Alabama, the following described Real property:

Begin at the NE corner of the SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 36, Township 21, South, Range 3 West, and run Southerly along the East side of the said  $\frac{1}{4}$ - $\frac{1}{4}$  Section for 203.66 feet; thence turn an angle of 81 degrees 13' 31" to the right and run Southwesterly for 601.65 feet; thence turn an angle of 85 degrees 07' 11" to the left and run Southeasterly for 10.03 feet to the point of beginning; thence continue Southeasterly along the last described course 551.82 feet to an existing iron; thence turn an angle of 96 degrees 00' 15" to the left and run Northeasterly for 521.44 feet to a point on the West right of way of Shelby County Road No. 107; thence turn an angle of 79 degrees 48' 37" to the left and run Northerly along the West right of way of said road for 546.42 feet; thence turn an angle of 99 degrees 03' 57" to the left and run Southwesterly along the South side of a 20-foot wide access easement for 560.49 feet back to the point of beginning. Situated in Shelby County, Alabama.

It being distinctly understood that all the other terms and provisions and the other property described in said above described mortgage shall remain in full force and effect.
