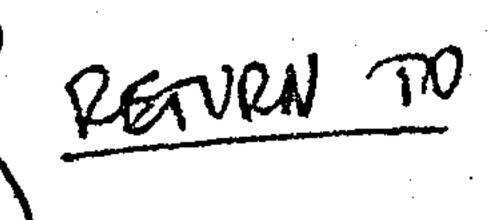
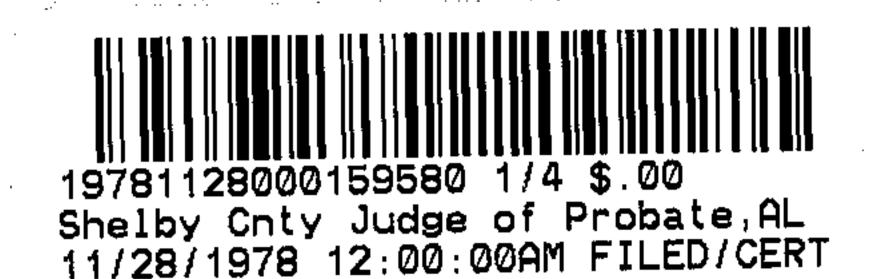

## STATUTORY WARRANTY DEED

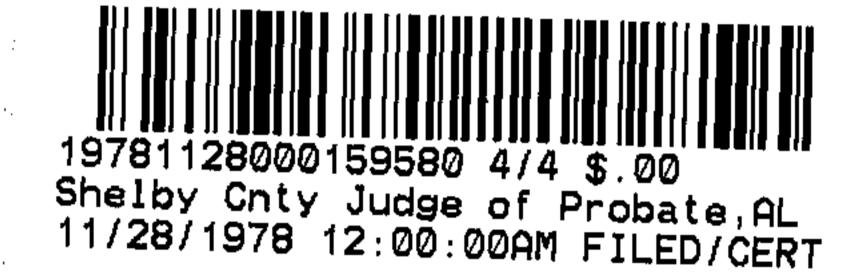
