A tract of land situated in the South half of the SW¹/₄ Section 31, Township 19 South, Range 2 West, Shelby County, Alabama. Said tract of land being more particularly described as follows:

Commence at the SW corner of the SW¹/₄ of SE¹/₄ Section 31, Township 19 South, Range 2 West, thence East along the South line of said ¹/₄-¹/₄ section for 986.04 feet to the Southeast Right of Way line of Oak Mountain Park Road said point also being the point of beginning of the property herein described; thence turn an angle of 50° 13' to the left and run Northeasterly along the Southeast boundary of said road for 69.12 feet to the point of beginning of a curve to the right concave Southeasterly; last described line being tangent to said curve; said curve having a radius of 634.50 feet and a central angle of 60° 05' 05"; thence continue along the South boundary of said road and along the arc of said curve for 665.18 feet to end of said curve; thence continue along the tangent to said curve for a distance of 27.84 feet; thence turn an angle of 27° 08' to the right and leaving the right of way of said road and run in a Southeasterly direction for 118.81 feet to the intersection of the South line of the SE¹/₄ of SW¹/₄; thence turn an angle of 122° 59' 55" to the right and run West along said South line of said ¹/₄-¹/₄ for a distance of 241.44 feet to point of beginning.
