WHEREAS, a declaration signed by the owners of all of the lands abutting the hereinafter described alley situated in the Town of Calera, County of Shelby, State of Alabama, vacating said alley had been duly presented to the Town Council of the Town of Calera, Alabama, for the assent and approval of said governing body, said declaration with map attached being hereto affixed, marked Exhibit "A", and made a part hereof, and

WHEREAS, the alley above referred to is more particularly described as follows:

That certain alley running East and West across the center of Block 200. The west terminus of the same being 7th Street and the east terminus of the same being 5th Street, all according to the Dunston Survey and Map of the Town of Calera, Alabama, made on October 1, 1886.

WHEREAS, it appears to the Town Council of the TOWN of Calera, Alabama, that the vacation of said alley is in order and that convenient and reasonable means of ingress and egress is afforded to all other property owners owning property in the subdivision embraced in said plat or map of Dunston Survey of the Town of Calera;

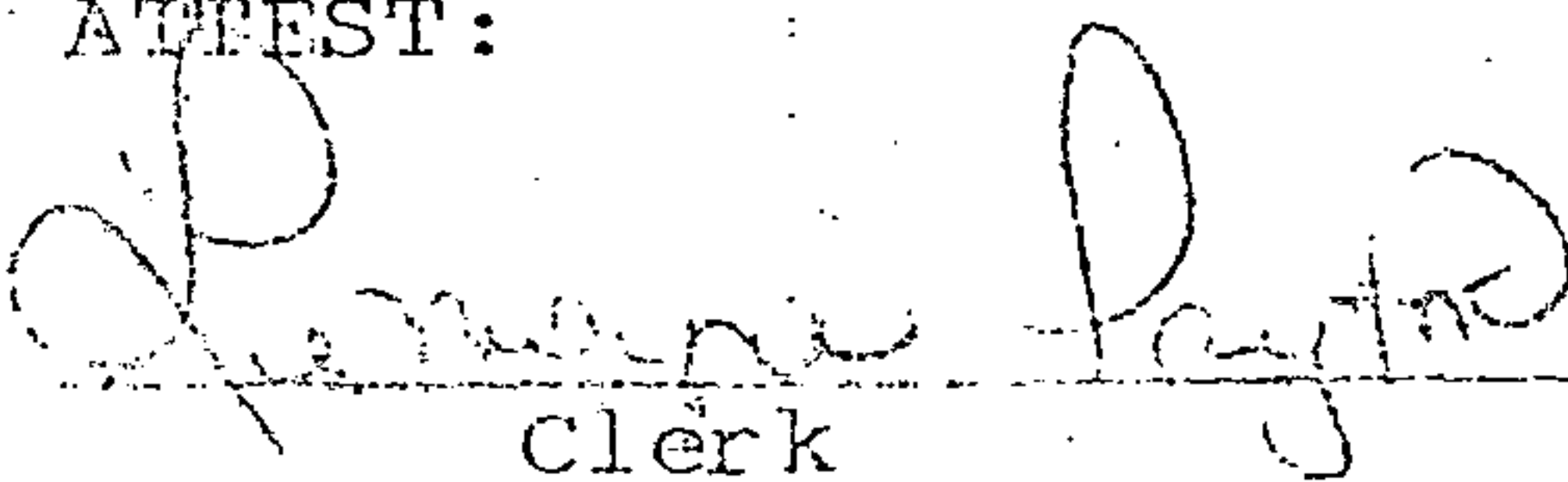

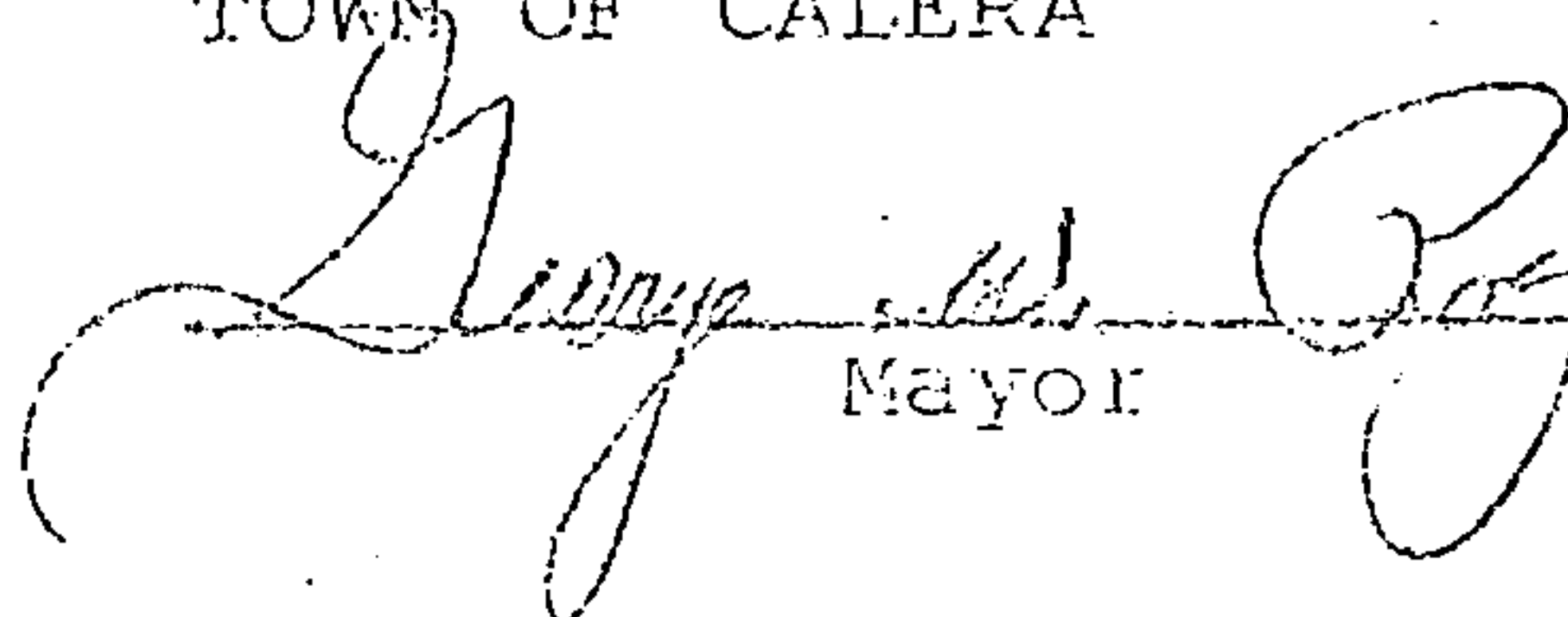

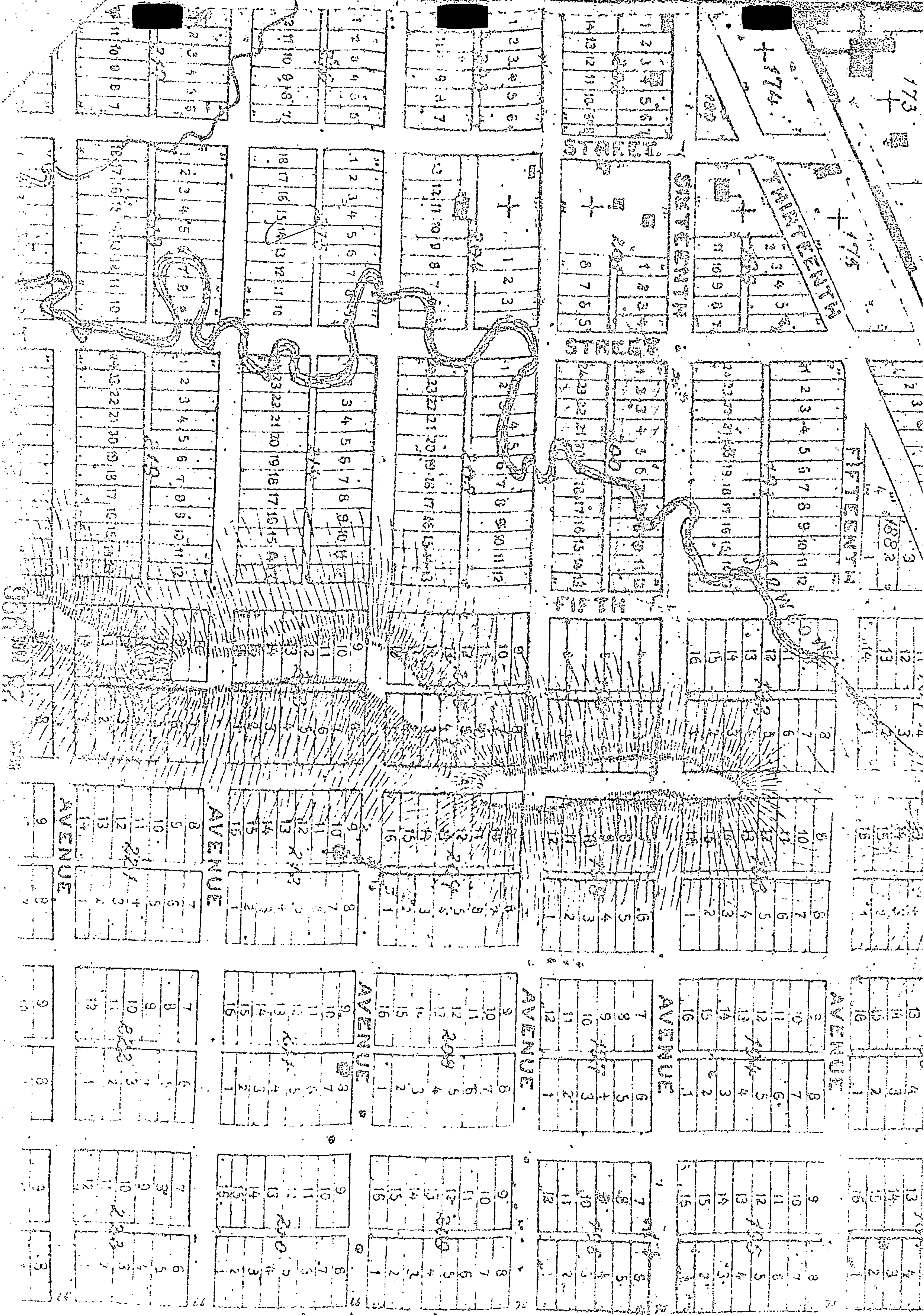
