

MEMORANDUM OF LEASE AGREEMENT

- 4. Date of Lease: April 25, 1978.
- 5. Description of leased premises as set forth in Lease: Lots 3, 4, 5 and 6, Block 2, according to the Survey of Cedar Grove Estates, as recorded in Map Book 3, Page 53, in the Office of the Judge of Probate of Shelby County, Alabama.
- 6. The manner of determining the date on which the Lease commences, as set forth in Lease, is as follows: Beginning on the 1st day of the calendar month next succeeding the date on which Tenant completes construction of its restaurant building on the premises, and/or the date on which Tenant shall open its business on the premises, but in no event later than six months after the date of this Lease.
- 7. Term of Lease: Twenty-five years after rental becomes payable, as set out in Paragraph 6 hereinabove.
- 8. Date of Expiration of Final Period for which Lease may be Extended: Tenant shall have the right and option to renew this Lease for two additional periods of five years each, provided that Tenant notifies the Landlord thirty (30) days in
