

Last Will and Testamentof

I, Raymond R. Lowery of Shelby County, Alabama, being of sound mind and disposing memory and being mindful of the certainty of death and of the uncertainty of life, do hereby make and publish this, my last will and testament, hereby revoking all former wills, if any, by me at any time made:

ITEM ONE: It is my will that all of my legal debts and funeral expenses be paid as soon after my death as is practicable.

ITEM TWO: I will, devise and bequeath to Allen Scott Paulk and Kellie Cheree Paulk, share and share alike, the following described real property:

All that part of the following described land lying north of County Highway No. 13: NE $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 34, Township 20 Range 4 West lying West of Hurricane Creek, situated in Shelby County, Alabama, less and except portions heretofore sold. The parcel being conveyed to said persons named herein contains 8 acres, more or less.

ITEM THREE: I will, devise and bequeath to my niece, Sarah Carter, my house and furnishings, plus ten acres of land now occupied by me and my said niece, Sarah Carter, for her use and enjoyment during her lifetime.

ITEM FOUR: In the event my niece, Sarah Carter, is not living at the time of my death, I will, devise and bequeath to my nephew, Steven Levon Paulk, the property described in Item <sup>R. P. L.</sup> Three above.

ITEM FIVE: After the payments of any bills, including the costs of the administration of my estate, then I will, devise and bequeath to my niece, Sarah Carter, the balance of any money left in Banks (Alabaster and Bessemer) and also any bonds which I may own, and a 1968 Plymouth Fury automobile.

ITEM SIX: I will, devise and bequeath to my sister-in-law, Ella Ray Paulk, one 1964 Model Ford Pick-Up  $\frac{1}{2}$  ton truck.
