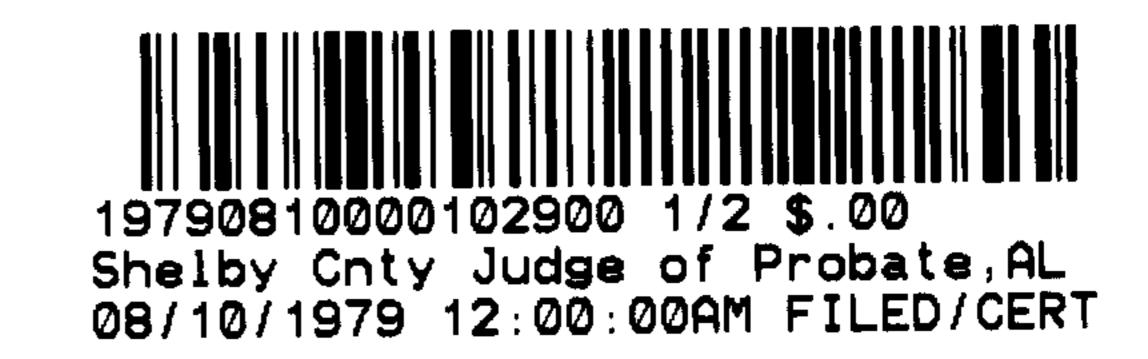

STORM EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One and no/100 (\$1.00) Dollars, cash in hand paid to Wren Development, the receipt of which is hereby acknowledged, we, the undersigned, do hereby grant, bargain, bestow and confer unto Shelby County, Alabama, and for the public interest, their successors and assigns, an easement, said easement being for storm drainage purposes only, and said easement being described as follows, to-wit:

STORM EASEMENT NO. 1

The following is a description of a 10.0 foot wide storm drainage easement situated in the S.W ½ of the S.E.¼ of Section 19, Township 19 South, Range 2 West and the N.W. ¼ of the N.E. ¼ of Section 30, Township 19 South, Range 2 West, Shelby County, Alabama, the centerline of which is more particularly described as follows:

Commence at the S.E. corner of Section 19, Township 19 South, Range 2 West; thence West along the South Line of said Section 2107.39 feet; thence 90° 00' 00" Right 111.10 feet to the point of beginning; thence 95° 30' 29" Left, 103.18 feet; thence 30° 33' 27" Left; 157.81 feet; thence 65° 30' 24" Left, 293.95 feet; thence 51° 30' 59" Left, 159.07 feet; thence 12° 49' 03" Left, 132.10 feet to the S.E. Property Line of Parcel 2 and the end of said easement.

STORM EASEMENT NO. 2

The following is a description of a 10.0 foot wide storm drainage easement situated in the S.W. ½ of the S.E. ½ of Section 19, Township 19 South, Range 2 West and the N.W. ½ of the N.E. ½ of Section 30, Township 19 South, Range 2 West, Shelby County, Alabama, the centerline of which is more particularly described as follows:

Commence at the N.E. Corner of Section 30, Township 19 South, Range 2 West; thence West along the North Line of said section 2417.37 feet; thence 90° 00' 00" Left 0.74 feet to the point of beginning; thence 96° 27' 48" Left 80.22 feet to the end of said easement and a point on storm easement No. 1.

STORM EASEMENT NO. 3

The following is a description of 10.0 foot wide storm drainage easement situated in the N.W. ½ of the N.E. ¼ of Section 30, Township 19 South, Range 2 West, Shelby County, Alabama the centerline of which is more particularly described as follows:

Commence at the N.E. corner of Section 30, Township 19 South, Range 2 West, thence West along the North line of said Section 1870.48 feet; thence 90° 00' 00" Left, 174.11 feet to the point of beginning; thence 12° 06' 40" Left, 20.11 feet to the S.E. property line of Parcel 2 and the end of said easement.

STORM EASEMENT NO. 4

The following is a description of 10.0 foot wide storm drainage easement situated in the N.W. ½ of the N.E. ½ of Section 30, Township 19 South, Range 2 West, Shelby County, Alabama the centerline of which is more particularly described as follows:

Commence at the N.E. corner of Section 30, Township 19 South, Range 2 West; thence West along the North line of said Section 2528.14 feet; thence 90° 00' 00" Left, 325.18 feet to the point of beginning; thence 100° 20' 10" Left, 253.57 feet to the end of said easement and on a point on Storm Easement No. 1.
