ITEM ONE: I desire and I hereby direct that all of my just debts, including my funeral expenses and the expenses of my last illness, be paid by my executrix or executor hereinafter named as soon after my death as convenient.

ITEM TWO: I hereby give and grant unto my executrix or executor full power and authority to sell any or all property owned by me at the time of my death, real, personal or mixed, at private or public sale without order of court.

ITEM THREE: All the rest, residue and remainder of my estate, real personal and mixed, I give, devise and bequeath unto my beloved wife, Katherine W. Bolton, if she be living and if not then to my son Arthur P. Bolton Jr.

I hereby nominate, constitute and appoint Katherine W. Bolton, executrix, if she be living, and if not, then Arthur P. Bolton Jr., executor of this my last will and testament, but without bond, and I expressly declare that my executrix or executor shall not be required to file any statement or make any report to any court of his acts and doings in his official capacity.

In witness whereof, I, the said Arthur P. Bolton Sr. have hereunto set my signature and seal on this the 22nd day of January, 1958, hereby declaring the instrument contained on this page to be my last will and testament.

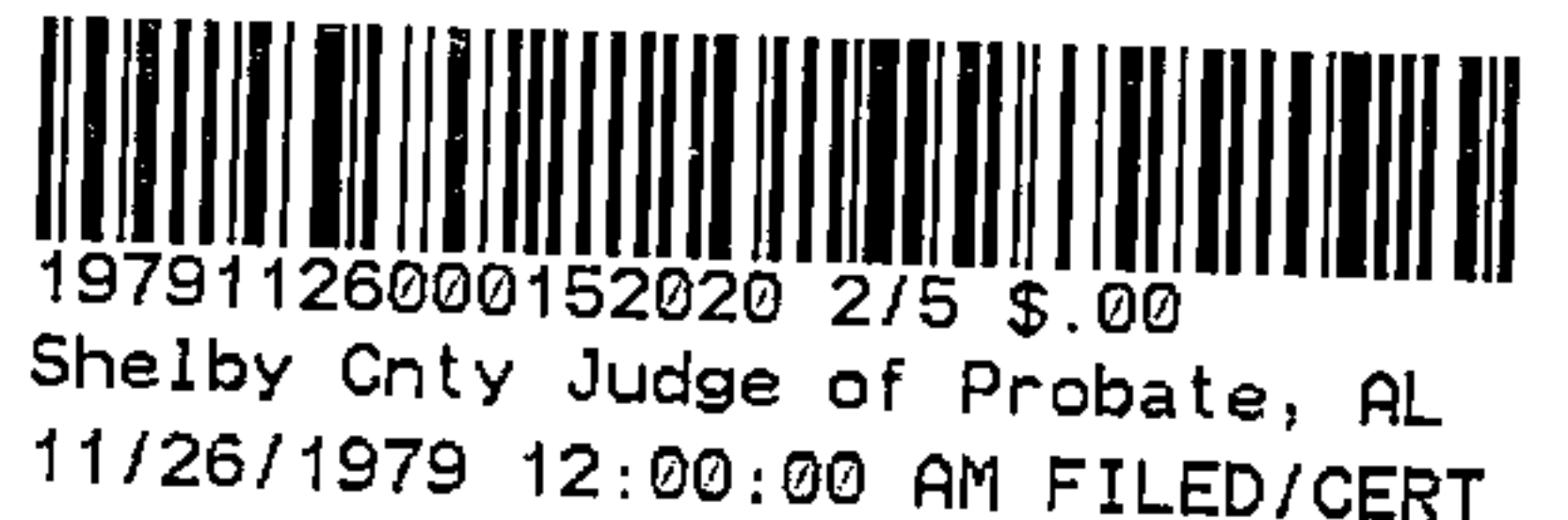
